Travis Paeper, Sheriff, met to discuss the Milnor City Police Contract with Sargent County. Jerry Waswick, Police Commissioner and Sheriff Paeper attended a Milnor City Council meeting and the Council is concerned whether they are getting the hours that were scheduled through the contract. After further discussion, they agreed the hours are being worked but the city would like more time and would like to hire Chris Sandvig to patrol an additional 5 hours per week. Milnor City does not own a car and would like to reimburse the county for use of the car. There are some liability issues and following discussion the commission directed the Sheriff to contact Milnor City with these concerns.

The culverts between Section 13/14/23/24-131-55 are not properly sized and creating problems with flow of the water. The SC Water Board will be contacted and culvert sizes reviewed.
