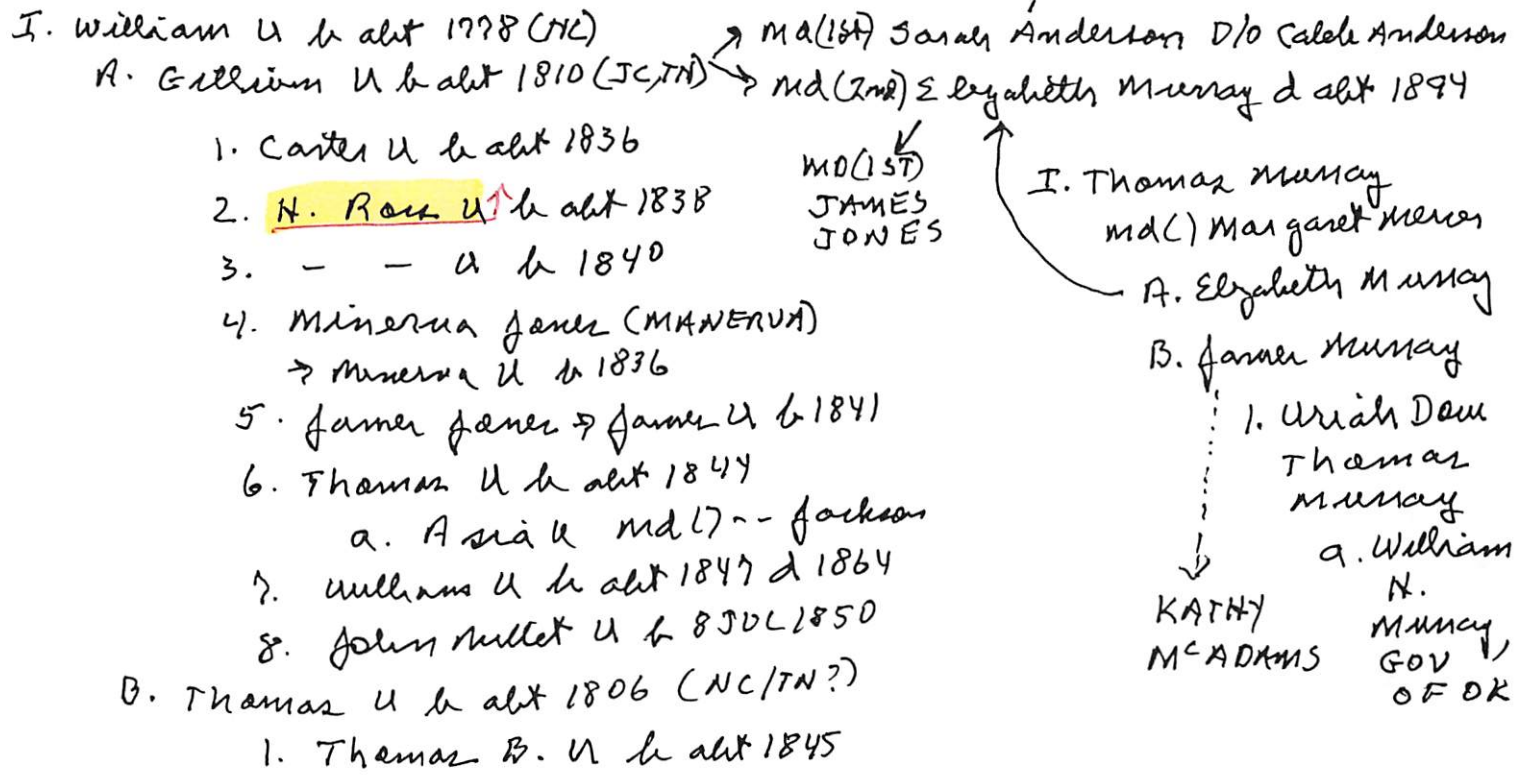

My confirmation of this comes from the research of Governor William H. Murray of Oklahoma...He was the great grand son of Thomas. His grandfather was James Murray and his father Uriah Dow Thomas Murray all three from Jackson co. I am from this same line and I have been researching the Murray's of Jackson County.

James did not take the Upchurch name, this must have been an assumption by the census taker on the 1850. I have a letter written by R.J.C. Gailbreath from a Civil War Camp near Lewisburg, Greenbriar Co. VA. dated: December 3, 1861. This Gailbreath was the brother of Thomas Jefferson Gailbreath, the husband of Eliza Murray Upchurch's sister Margaret Murray (you will find the Murray family detailed in this letter)

From letter: "Give my love to our kind old mother, and that I was glad to hear that she was well, her son Thomas L. Clements (RJC married a Clements) is here somewhere in VA but I have not seen him yet, but hope I will. Eliza Upchurch's son James Jones is here and well. Bill A. is as fat and sassy as a bear and gets along fine. Dave and Tom Haile is well and Tom is engaged writing a letter" and so on.

I assume that Manerva is the daughter of Eliza Jones-- a child of hers before she married Gillum. On the 1840 census for Gillum Upchurch there is no young female. On the 1840 census for James Jones there is. No proof, just circumstantial. I have found no census records for James Jones. There is a record in Jackson County Deeds - Index to Jones Deeds. Roll#30 Sept 1872 to April 1915: Upchurch, Gillem to Jones, Jas book H, page 526. This may be his step- son James, but I have not seen this record. There is another record on this list that may be of interest to you: Jones, J.W, to Upchurch, J.M. book B page 441.

C. H., H. R. AND JOHN M. UPCHURCH are children of GILLUM UPCHURCH.

[Blank] day of 1845 GILLUM UPCHURCH purchased in 11th District 64 acres [metes & bounds description included] decreed to WM C. ANDERSON by CALEB ANDERSON; subsequently conveyed to HILLIARD J. ADKINS by said ANDERSON. HILLIARD J. ADKINS on [blank] day 1845 for [\$ blank] sold GILLIUM UPCHURCH land in fee simple. 6 August 1860 GILLUM UPCHURCH sold and conveyed said land to JAMES JONES; deed registered [blank] day of 186 [blank]. 6 July 1877 JONES sold same land to JOHN M. UPCHURCH, registered 31 July 1877. On 11 Oct 1899, JOHN M. UPCHURCH sold land to BYRD ANDERSON, recorded 19 Oct 1899.

18 July 1885, land was levied on by W. C. MORGAN, Sheriff of Jackson County to satisfy judgment against GILLUM UPCHURCH. Land was bid off by J. T. ANDERSON. 20 March 1893, long after GILLUM UPCHURCH'S right of redemption expired, JOHN M. UPCHURCH bought from J. T. ANDERSON for \$143.00.

States true that GILLUM UPCHURCH first married SARAH ANDERSON, daughter of CALEB ANDERSON. She died 1839 or 1840.

Denies remainder of charges. Respondents say many years ago 21 May 1859 and 22 October 1858 complainant H. R. UPCHURCH and his brother C. H. UPCHURCH both sold to L. H. McCARVER their entire interest in the estate of their mother SARAH UPCHURCH. States true that GILLUM UPCHURCH sold to JOHN M. UPCHURCH the 70 acre tract for caring for him the rest of his life, but that consideration was inadvertently left out of deed.

States untrue that GILLUM UPCHURCH drew pension ever since 1889 as stated.
