Another new project in the works is the FRRL FXpedition. Those who attended the February meeting learned that the club is on a yearlong "fishing" expedition. We're fishing for ideas, and each month, members will have the opportunity to share their thoughts about new avenues that we as a group might explore. Forms will be distributed at each meeting and collected in the fish bowl that will be passed around. The information that is gathered will be compiled and discussed at the following month's board meeting. After a few of these "fishing trips," I expect that we'll have a clear picture of the kinds of activities and projects members would like to see. Be sure to "take the bait" so we can reel in your ideas!

While we collectively begin to move in new directions this spring, what about you as an individual? The first few years in the hobby, *everything* presents something new to learn.
