

If the plan proves to have merit, the membership will be asked to give it a try in their respective areas. Clyde Martz believes that many sportsmen will support any sport activity by becoming a supporting member.

To all State Secretaries—A second request is being made by NHPA Publicity to have all state secretaries send in the location of all major courts sites in their state. Also, the approximate dates of all tournaments and the names and addresses of all tournament directors and state secretaries.

NHPA SECRETARY'S NOTE TO ALL STATE OFFICERS

Have you carefully read and do you fully understand the red league booklet and the program that it describes? We now have 100 leagues nation-wide involved in the program with nearly 5000 people signed up. The program has become very, very successful and growing rapidly. We pro-

bably have some leagues involved in your state.

If you have read the book you know that each pays a \$2.00 membership and receives a league card. Out of this \$2.00 we keep 90¢ to pay for the program and awards. Of course we lose money on it. 10¢ is rebated to the league. \$1.00 is sent to the state association by me. So we credit each member with \$1.00 paid on NHPA dues and \$1.00 paid on state dues. So, if your state dues are \$3.00 and NHPA dues are \$6.00 and one of these league people decide to buy a full card which many do, you would collect \$2.00 state dues and \$5.00 NHPA dues from them. People who purchase the full membership card don't have to pay for a league card.

So if you sell a league person an NHPA card, you need only send me \$5.00 as you collected. The \$1.00 of state dues is refunded to the state in January. Women and Juniors are same as men in

the league program.

Starting in 1983 you will receive a copy of all league rosters so that you will know who has purchased a League Card. This should be a great help to you. I might point out that the cost of the League program will likely be \$3.00 in 1983. \$2.00 to support the program and \$1.00 state dues. This will give a credit of \$2.00 toward the \$6.00 NHPA dues. So you would collect \$4.00 from a league person.

If you haven't done so, please study the League program book as it is the best program that the

NHPA has ever had.

NHPA PROMOTION COMMITTEE REPORT

Don Titcomb, 1980 World Champion, organized a well-rounded program at the Santa Clara County fair, to attract passers-by to the Sport of Horseshoe Pitching. 10,000 fans pitched. Don and Walter Ray Williams performed in 44 exhibitions during the 11-day fair. Sixty new members joined the Golden Eagles Horseshoe Club.

Don missed the World Championship in order to organize this great promotion.

The National Senior Sports Association has been contacted. They expressed the possibility of

working with the NHPA in some co-sponsorship of senior events around the Country.

A videotape is being prepared called "Trick Shots"—it will include Danny Kuchcinski on the 1968 Johnny Carson show, Floyd Toole 1950 Short with Harry Weisner narrating, Trick shots by myself, Jack Fahey doing tricks on the PM Show, Trick Shots by Carolyn Schultz Decker 1940 and Danny & Sue Kuchcinski on the "You Asked For It" show.

Legends of Horseshoes-Ed McFarland suggested that the NHPA put together a film on the

"Legends of Horseshoes."

The executive council voted that they were not financially able to support the project at this time.

ALLEN, LABBE, WETHERBEE, D. BOSS, ROGERS, TIILIKAINEN COLORADO STATE HALL OF FAME INDUCTEES.

Six Colorado horseshoe pitchers were honored as tops in their field when they were inducted as charter members into the Colorado Horseshoe Pitchers Association's Hall of Fame.

Ceremonies to honor Ted Allen, Gerry Labbe, and Dick Wetherbee for horseshoe pitching excellence and Dale Boss, George Rogers and Eino Tiilikainen for service to horseshoe pitching were held at the annual meeting of association members at Windsor's Firehouse Restaurant.

Allen and Boss are from Boulder, Labbe and Rogers from Denver and Wetherbee and

Tillikainen from Colorado Springs.

Each was given a plaque with a replice of a full-size horseshoe mounted on walnut with proper

inscriptions on two plates mounted above and inside the light wood shoe.

A permanent plaque will be displayed at state tournaments next year. Individual plates of the six new members and future members will enhance the plaque. It is the plan of the committee to elect at least one Hall of Fame member each year in each category.

Members of the Hall of Fame Committee were Chairman Bob Champion, Boulder; Association president Bob Engel, Nunn; Vice President Jim Tulk, LaSalle; Regional Director Dale Boss, Boulder, immediate past president Al Perry, Jr., Denver; and Earl Graves, Arvada; and Earl Graves, Wheatridge, member at large.

Voting members were the officers and all past-presidents — Perry Graves, George Rogers, Wheatridge; Gerry Labbe, Denver; Bill Bryan, Pierce; Les Grosenbach and Harry Russell, Arvada;

and JAck Beebe, Boise, Idaho.

The legendary Ted Allen was world champion 10 times and won the Colorado State Championship the same number of years. He holds the world's record of 72 straight ringers, and has been

noted by followers of the sport as the "Babe Ruth of Horseshoe Pitching."

He competed at the World level 31 years and won his first title at the tender age of 24 in 1933. Allen earned a living in those days during his prime doing exhibitions of fancy pitching at rodeos, sports shows and stage appearances. Allen has been manufacturing and selling his brand of horseshoes since 1938, a business that still flourishes. He was director of the Boulder Rocky Mountain open for 23 years.

Gerry Labbe of Denver won the state title five times — 1951, 1958, 1960, 1961, and 1962. He pitched in Class A from 1949 and competed in three world tournaments finishing in the top eschelon

each year.

Labbe is currently test engineer at Electron Corporation in Littleton.

Dick Wetherbee is still competing in the Class A level. He won the state championship six times, twice in a row on three occasions — 1966, 1966, 1970 and 1971, and '77 and '78. He has


been a prime contender since 1962.

Dale Boss has been regional director for two years, and was recently elected secretary of the association for 1982-83. He was secretary four years prior to 1982. Boss was instrumental in the increase of members in the association, has guided the Boulder Tournament six years, and has been helpful in organizing tournaments and horseshoe clubs for many years. He is employed at AMF Head Tennis in Boulder.

Rogers was president of the association in 1973, '76 and '77. He also served as secretary for two years prior to his presidency. George has run the indoor Cancer benefit Speakeasy tournament three years and recently completed the 10th outdoor Speakeasy benefit in Denver. He was the guiding force in the construction of 18 horseshoe courts at Denver's Rocky Mountain Park on 46th Street in 1975.

Eino "Tilly" Tillikainen was an active member of the Colorado association for many years. He was secretary-treasurer for 16 years beginning in 1951. Tilly literally ran the association tournaments during those years, and still has many active records at his home in Colorado Springs. He follows the weekend tournaments as if he was still pitching and servicing the horseshoe group. Tilly was also a fine pitcher, winning the Class A title three times — 1949, '50, and '53. He is retired from his position as draftsman at the Air Force Academy.

Dear Editor.

A few comments about the 1982 World Tournament in Huntsville, Alabama: There were some excellent and exciting games as the 40 point game seemed to provide more surprises. There were 3-way playoffs in Women's B and Men's A. There were four women of the 72 that entered that pitched 78% or more, the best showing ever for women and a portent of things to come.

However, if it had not been for an enterprising young women from Huntsville by the name of Rosemarie Bonebrake, there would have been no stories or photos in our own Horseshoe Digest. It seems quite possible in the future that the publicity and promotion committees could arrange for this ahead of time. Horseshoe pitchers above all others should have news and photos about their World Tournament.

"From Out of the Mailbag" - (Continued)

The hardest thing to understand was the great (and increasing) disparity in the prize money for men and women. The first two places in the Mens' A Division received a total of \$3800, \$1100 more than the *entire* Women's Championship Class. The Men's World Champion received \$2500 or **only \$200** less than the top 12 women **combined**. Our Womens' Champion, Phyllis Negaard, received only 40% of what Dale Lipovsky received. Did she work only 40% as hard as he? The top twelve men received a total of \$8,040, 3 times what the top twelve women received. We did vote at the 1982 World Tournament NHPA Convention to maintain a minimum of \$1000 for Women's first place. In the near future, we hope that the top twelve women will equal the top twelve men in prize money.

Please think about the statistics I have written here. Thank You.

In Memoriam

The Ohio Buckeye Horseshoe Pitchers Association regrets to report the passing on of Harold Wolfe of Cedarville, OH, October 5th, at age 76. An outstanding pitcher and organizer in horseshoe pitching for 52 years.

Harold started pitching in 1930. He was a member of the AAU Amateur League and pitched with a traveling team before tournament pitching came about. A member of the NHPA since 1945

Harold entered state competition in 1947.

He attended the World Tournaments from 1955 until his physical ailments forced him to quit pitching about five years ago. He won the World Class C title in 1961 and finished 34th in the World in 1962.

He was a member of the Ohio Buckeye State Horseshoe Pitchers Hall of Fame. A gentleman and an outstanding sportsman. He will be sadly missed by many friends and associates.

To his bereaved family, we extend our sincere sympathy.

The Wisconsin Horseshoe Pitchers Association was saddened by the passing away of Bill Glass on September 5, 1982 at the age of 61.

Bill started pitching horseshoes as a youngster in Ohio. He pitched on and off for 25 years. In 1960 he moved to Wisconsin. After no horseshoe pitching for 15 years, Bill decided to enter the

1966 State Tournament winning Class B.

He won the Wisconsin State Title eight times, his first in 1968 and subsequently in 69, 70, 71, 74, 78, 79, and 80. He was unable to enter the 1981 State Tournament due to Lou Gehrig's disease. In the winter of 1980, Bill vacationed in Florida. He entered eight tournaments while there, winning four of them. Bill was inducted into the Wisconsin Horseshoe Pitchers Hall of Fame in 1981.

Bill farmed in Vesper, Wi. with his wife and five children. The sympathy of the Wisconsin Horseshoe Pitchers Association and that of the NHPA is extended to his wife and family. He was always a tough competitor and a true champion. He will be missed by all.

The Utah State Association was saddened by the passing of Mrs. Elma Couch, wife of Wilbur Couch, a member of Utah State Hall of Fame on November 10, 1982. She is survived by her husband, one son, two daughters and several grandchidren and great-grandchildren. The sympathy of the NHPA and that of the Utah Association is extended to the bereaved family.

NEW LIGHT SHINES ON HORSESHOE PITCHING By Stewart Snyder

A sideshow barker gets attention at the County Fair — Don Titcomb is not a sideshow barker, but he got plenty of attention at the County Fair this year in San Jose, California. Periodic loudspeaker announcements called attention to the horseshoe pitching for eleven days from 11 a.m. until dark. The horseshoe stand was favorably located adjacent to the carnival.

This was no sideshow of make believe or slight of hand, for Don Titcomb, (world champion 1960) had organized a well-rounded program to attract passerby to the sport of horseshoe pitching. This program is believed to be the first of its magnitude to appear in the United States.

Scheduled pitching events at the San Jose Fair were varied — fairgoers were invited to toss four horseshoes in a "pitch & win" event. If they 'came close enough' they received a button on





which was written, "I Scored at the Fair". Ten thousand fans pitched 4 shoes trying to win a button — 7,000 were given away; a free amateur tournament struck a line of competitiveness among the old and young who tried their skill; many, perhaps, for the first time. This event drew 1419 qualifiers (men, women and children) whose ages ranged from 6 years to senior citizen toddlers. There were 40 trophies (\$500 worth) for the winners; Don and Walter Ray Williams, Jr., also a world champion pitcher, performed in 44 pitching exhibitions to show the crowds what real pitching is all about; a \$2,000 pro tournament for men, women, juniors and seniors, on the last two days, completed activities at the horseshoe pitching stand.

During the 11-day exhibition, 60 individuals signed up to become new members of the Golden Eagles Horseshoe Club. Don emphasized that follow-up is an essential part of the program and he has sent letters to 200 potential members.

Since this boost in membership, the San Jose Recreation Department has pledged \$50,000 to establish a new 24-court pitching area.

Don is a member of the San Jose Golden Eagles Horseshoe Club. Verdan Zelmar, president of the club, coordinated activities from inception to conclusion. Cooperative effort by members of the club constructed 4 portable courts for amateurs, 10 for the professional tournament and a sheltered booth, at a cost of \$3,500.

Co-sponsors of this horseshoe pitching "show" were three local businesses, generously assisted by Diamond Tool and Horseshoe Company of Duluth, Minnesota. Without financial and moral support from the Santa Clara County supervisors who operate the fair, this sporting event could not have been realized. With justifiable pride, Don called this program 'The best of it's kind anywhere.'

HORSESHOE PITCHING — (Cont.)

In Ontario, Canada, Paul Carriers, a professional horseshoe pitcher of note, has initiated a program to accomplish the same objective—to advance the state of horseshoe pitching. He is responsible for introducing the game during the past school year to 600 junior and senior high school student and to parapalegics. Working in close association with schools' athletic directors, Paul teaches pitching on portable courts in classes of 40 students for the duration of class periods. Special attention is given by demonstration to proper technique in all aspects of the game.

Popularity of these classes is growing, especially in the Toronto area where they were introduced. Paul reported during this year's World Tournament in /Alabama, that he was already (in July) receiving inquiries from athletic departments in other schools for his voluntary assistance in

establishing classes for the fall semester.

Paul said, "My altruistic aim is to make kids aware that the game exists; to expose them to the

game."

Could it be that the enlightening San Jose experience, and the one in Ontario, might set patterns for similar nationwide demonstrations to awaken interest in the sport of horseshoe pitching?
