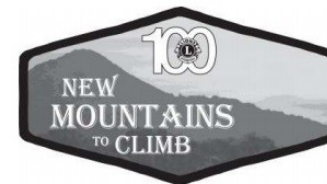

MONTHLY MEMBERSHIP REPORT

Clubs that report online through MyLCI, must enter report data by the **last day of the current month**. Clubs that file paper MMR reports, must submit paper MMRs to LCI by the **20th of the current month**.

Transactions entered on MyLCI will be reported in the current month. For example, transactions entered on July 7th will be considered a "July" reporting. Mailed reports must be mailed in enough time to be **received** by LCI by the 20th of the current month.

CLUB OFFICER REPORTING

Incoming officers should be reported via MyLCI by April 15. Information reported via MyLCI has been expanded to include the Club's incoming President, Secretary, Treasurer, Membership Chairperson, and Vice President(s). Membership information should be updated, if necessary, prior to officer reporting so that information provided in the district directory is accurate.

INTERNAL REVENUE SERVICE FORM 990

All Lions Clubs are required to file an annual electronic notice: **Form 990-N**. If your club has been filing the IRS Form 990 or Form 990EZ, you will continue to do so in the same manner that you have been doing. Previously clubs whose gross receipts were less than \$25,000 were not required to file a tax return with the IRS. **Now all tax exempt entities will be required to file.**

If your club normally has annual gross receipts of \$50,000 or less and does not have to file Form 990 or 990-EZ, you must file the e-Postcard (also known as 990-N). The e-Postcard is due by the 15th day of the fifth month after the close of your tax year. Lions Clubs operate on a fiscal year, July 1 – June 30, and the e-Postcard will be due by November 15.

All Lions clubs are exempt from federal income tax under IRS code section 501(c) 4; however, if you don't file, you risk losing your tax-exempt status. Any Lions Club that fails to meet its annual reporting requirement for three consecutive years automatically loses its tax-exempt status under the new law.

The e-postcard (Form 990N) will be filed electronically and does not require a paper form. It is internet based and does not require special software. If you do not have access to a computer, you can file at your local library.

2016-2017 CLUB EXCELLENCE AWARD

In order to receive the Club Excellence Award, each club that has qualified must have the club secretary fill out the form provided on the district website and have it approved and signed by the district governor. The award will be mailed to the 2017-2018 District Governor for presentation.

THE FOLLOWING REQUIREMENTS MUST BE FULFILLED

1. CLUB IN GOOD STANDING. International dues and new member entrance fees are paid in full and there is no outstanding balance of \$50 or more than is ninety (90) days past due.

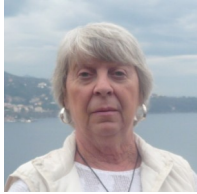
2. SERVICE. The club has conducted at least three service projects.
3. CONTRIBUTION. The club has made a contribution to LCIF.
4. MEMBERSHIP. The club has achieved a net growth in membership (including branch club members when applicable) OR sponsored a new club. The new members attended an orientation and were properly inducted into the Lions Club.
5. COMMUNICATION. The club has published the club's service activities to the public through local media and effectively communicated activities to club members.
6. LEADERSHIP DEVELOPMENT. All officer positions were filled in accordance with the constitution and bylaws by qualified Lions, a majority of the club officers participated in a leadership training program at the zone, district, multiple district or international level and the club was represented at zone meetings.
7. CLUB DEVELOPMENT. The club has hosted regular and meaningful club meetings and submitted the Monthly Membership Report, the Service Activity Report, and the Club Officer Report (PU-101) in a timely manner.

RULES FOR DISTRICT GOVERNOR'S 100% SECRETARY AWARD

All of the following requirements must be satisfied:

1. The club must be in good standing. International dues and new member entrance fees are paid in full and there is no outstanding balance of \$50 or more than is ninety (90) days past due.
2. The club has published the club's service activities to the public through local media and effectively communicated activities to club members.
3. The secretary has submitted the Monthly Membership Report and the Service Activity Report on time every month.
4. The secretary has submitted the Club Officers (formerly PU-101) by April 15.
5. The secretary must have accomplished four (4) of the following requirements pertaining to the current business year:
 - Sponsor a new member.
 - Attend two Cabinet meetings.
 - Attend at least two Zone meetings.
 - Attend a District, State, or International Convention immediately preceding or during his or her term.
 - Attend the District Officer Training session immediately preceding or during his or her term.
 - Attend the USA/Canada Forum immediately preceding or during his or her term.

**MELVIN JONES
FOUNDER OF
LIONS INTERNATIONAL**

Melvin Jones was born on January 13, 1879 in Fort Thomas, Arizona, the son of a United States Army captain who commanded a troop of scouts. Later, his father was transferred and the family moved east. As a young man, Jones made his home in Chicago, Illinois, became associated with an

insurance firm and in 1913 formed his own agency.

He soon joined the Business Circle, a businessmen's luncheon group, and was shortly elected secretary. This group was one of many at that time devoted solely to promoting the financial interests of their membership. Because of their limited appeal, they were destined to disappear. Melvin Jones, however, had other plans. "What if these men," he asked, "who are successful because of their drive, intelligence and ambition, were to put their talents to work improving their communities?" Thus, at his invitation, delegates from men's clubs met in Chicago to lay the groundwork for such an organization and on June 7, 1917, Lions Clubs International was born. It was stipulated that clubs were not to be social in nature nor were members permitted to promote their own business interests.

Jones eventually abandoned his insurance agency to devote himself full time to Lions at International Headquarters in Chicago. It was under his dynamic leadership that Lions Clubs earned the prestige necessary to attract civic-minded members.

The association's founder was also recognized as a leader outside the association. One of his greatest honors was in 1945 when he represented Lions Clubs International as a consultant in San Francisco, California, at the organization of the United Nations.

Melvin Jones, the man whose personal code "You can't get very far until you start doing something for somebody else" became a guiding principle for public-spirited people the world over, died June 1, 1961 at 82 years of age. **1925 International Convention
Cedar Point, Ohio, USA
June 30, 1925**

Dear Lions and Ladies:

I suppose you have heard the legend that represents opportunity as a capricious lady, who knocks at every door but once, and if the door isn't opened quickly, she passes on, never to return. And that is as it should be. Lovely, desirable ladies won't wait. You have to go out and grab 'em.

I am your opportunity. I am knocking at your door. I want to be adopted. The legend doesn't say what you are to do when several beautiful opportunities present themselves at the same door. I guess you have to choose the one you love best. I hope you will adopt me. I am the youngest here, and what I offer you is full of splendid opportunities for service.

The American Foundation for the Blind is only four years old. It grew out of the imperative needs of the blind, and was called into existence by the sightless themselves. It is national and international in scope and in importance. It represents the best and most enlightened thought on our subject that has been reached so far. Its object is to make the lives of the blind more worthwhile everywhere by increasing their economic value and giving them the joy of normal activity.

Try to imagine how you would feel if you were suddenly stricken blind today. Picture yourself stumbling and groping at noonday as in the night; your work, your independence, gone. In that dark world wouldn't you be glad if a friend took you by the hand and said, "Come with me and I will teach you how to do some of the things you used to do when you could see?" That is just the kind of friend the American Foundation is going to be to all the blind in this country if seeing people will give it the support it must have.

You have heard how through a little word dropped from the fingers of another, a ray of light from another soul touched the darkness of my mind and I found myself, found the world, found God. It is because my teacher learned about me and broke through the dark, silent imprisonment which held me that I am able to work for myself and for others. It is the caring we want more than money. The gift without the sympathy and interest of the giver is empty. If you care, if we can make the people of this great country care, the blind will indeed triumph over blindness.

The opportunity I bring to you, Lions, is this: To foster and sponsor the work of the American Foundation for the Blind. Will you not help me hasten the day when there shall be no preventable blindness; no little deaf, blind child untaught; no blind man or woman unaided? I appeal to you Lions, you who have your sight, your hearing, you who are strong and brave and kind. Will you not constitute yourselves Knights of the Blind in this crusade against darkness?

I thank you.

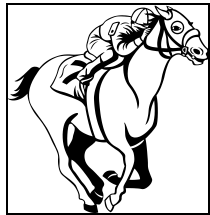

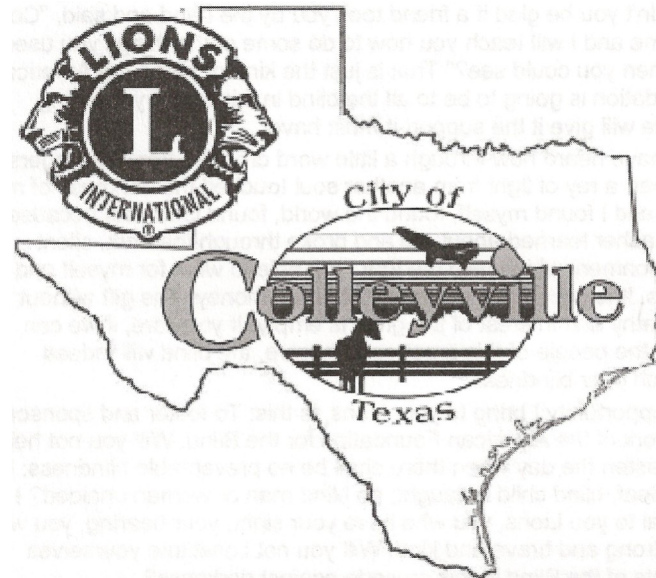

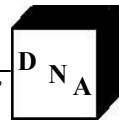

HISTORY OF THE INTERNATIONAL ASSOCIATION OF LIONS CLUBS

Officially formed October 1917

First President Dr. D. P. Woods, Indiana
 Vice President D. H. Lewis, Dallas, Texas
 Secretary-Treasurer Melvin Jones, Chicago, Illinois
 One Year Director C. H. Kirk, Houston, Texas

The first meeting convened with 36 delegates and eight alternates. There were 12 original clubs from Texas that joined Lionism when it was officially formed. These were Abilene, Austin, Beaumont, Dallas, Fort Worth, Houston, Paris, Port Arthur, San Antonio, Temple, Waco and Wichita Falls. These clubs are known as the Founder Clubs.

October 8, 1917, Texas became District 4. In 1921 District 4 became District 2 as a result of the International Convention in Oakland, California.

At the 1930 Convention held in Austin, Texas, District 2 was divided into five Districts: 2T, 2E, 2X, 2A and 2S.

After the 1942 Convention, District 2S was divided into three Districts: 2-S1, 2-S2 and 2-S3. This increased the number of districts to seven.

At the Convention held in 1947, District 2T was divided into two Districts: 2-T1 and 2-T2, bringing the number of districts to eight.

At the convention in 1958, District 2T was divided into three Districts: 2-T1, 2-T2 and 2-T3. This increased the number of districts to nine.

At the Convention in 1959, Texas divided into fifteen Districts: 2-T1, 2-T2, 2-T3, 2-E1, 2-E2, 2-X1, 2-X2, 2-X3, 2-A1, 2-A2, 2-A3, 2-S1, 2-S2, 2-S3 and 2-S4. At the convention in 1988, Texas was divided into sixteen districts adding 2-S5. There are still sixteen districts as of 2010.
