Recommendation: Grant Final 60-day extension.

- hh. Ford Motor Company: #10-27260-I-3 (Cook – Hyde Park)

Intervenor, Board of Education of the City of Chicago (CBOE), originally filed with PTAB on 1-11-13. A total of 120-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension due to previously scheduled professional and personal obligations of CBOE's expert witness, Kevin Byrnes, MAI.

Recommendation: Grant Final 60-day extension.

- ii. Capital World, Inc.: #10-22943-C-3 (Cook – Lake View)  
Illinois Parkway Garden Association: #10-26144-C-3 (Cook – Hyde Park)  
Commonwealth Edison: #10-26580-I-3 (Cook – Jefferson)  
HRH LLC: #10-27151-C-3 (Cook – Jefferson)

In each of the above listed appeals, Intervenor, CBOE, originally filed with PTAB on either 1-11-13 or 12-7-12. A total of 120-days has been granted for the submission of evidence. Intervenor is requesting an additional 30-day extension to submit evidence.

Recommendation: Grant Final 30-day extension in each of the appeals listed above.

jj. Andrea Vozar: #12-00094-R-1 (Macon)

Appellant originally filed with PTAB on 1-4-13, a Friday. This (1-4-13) is the ship date printed on the FedEx package containing the appeal form and evidence. The Final Decision issued by the Macon County Board of Review is dated 12-4-12. According to the 1-4-13 FedEx ship date, the appeal is one (1) day late. The appeal was dismissed on 6-26-13. Per correspondence dated, 7-2-13, the Appellant is requesting the PTAB reinstate the appeal and provides a FedEx order form. The order form is dated 1-3-13.

Recommendation: Deny request to reinstate appeal. Section 1910.25(b) of the PTAB's rules provides in part: "Petitions, evidence, motions, and all other written correspondence sent to the Property Tax Appeal Board by a delivery service other than the United States Mail shall be considered as filed with the Property Tax Appeal Board on the date sent as indicated on the tracking label."

kk. Polly Jacobs: #11-05636-R-1 (Monroe)

Appellant originally filed with PTAB on 8-18-12, a Saturday. This (8-18-12) is the postmark on the envelope containing the appeal form and evidence. The Final Decision of the Monroe County Board of Review is dated 7-18-12. According to the postmark, the appeal is one (1) day late. The appeal was dismissed on 5-20-13. Per correspondence dated, 6-4-13, the Appellant is requesting the PTAB reinstate the appeal. A hand-written paragraph on this request states the Waterloo post office mail goes to St. Louis to get postmarked and if it is received in St. Louis after midnight, it will receive a postmark date of the following day.

Recommendation: Deny request to reinstate appeal. Section 1910.25(b) of the PTAB's rules provides in part: "Petitions, evidence, motions, and all other written correspondence sent by United States Mail to the Property Tax Appeal Board shall be considered filed as of the postmark date in accordance with Section 1.25 of the Statute on Statutes [5 ILCS 70/1.25]."

ll. Riva Ridge Residential Association: #10-02497-R-3 (Lake)

A Final Administrative Decision was rendered by the PTAB on 6-21-13 for the above Residential Appeal. The decision was written based on the evidence presented in the file by all parties. A hearing was not held. The Appellant has filed a Motion for Reconsideration dated, 6-24-13. Appellant, through counsel, asserts the PTAB failed to accord appropriate weight to the 2009 sale and subsequent 2010 assessment of parcel 11-27-308-041.

Recommendation: Deny request to reconsider. Proper procedure is to file a complaint with Administrative Review.

mm. Shady Acres Townhouse Assoc.: #07-29220-R-1 (Cook – Thornton)

A Final Administrative Decision was rendered by the PTAB on 5-24-13 for the above Residential Appeal. The decision was written based on the evidence presented in the file by all parties. A hearing was not held. The Appellant has filed a Motion for Reconsideration Based Upon a Stipulation and 2008 Subsequent Reduction dated, 6-20-13. Along with this Motion is a stipulation for the 2007 appeal signed by the Appellant only and correspondence between Cook County BOR and Appellant's counsel regarding reductions for the 2008 tax year. Motion requests the PTAB vacate the 5-24-13 decision because of a previously reached agreement that the BOR, inadvertently, did not deliver to the PTAB.

Recommendation: Deny request to reconsider. File contains no stipulation executed by the Board of Review.

nn. Deer Creek Golf, LLC: #11-00856-C-2 (Will)

The Will County Board of Review filed a Motion to Stay with the PTAB dated, 6-4-13. The Motion requests a stay on the proceedings in order for the PTAB to finalize the decision on Onwentsia Country Club with the intent to incorporate the merits of the final decision on Onwentsia into an offer for Deer Creek Golf Club. The BOR contends that since the Onwentsia case has not been fully adjudicated, a case with the same or similar merits to be held would be duplicitous and/or lead to additional court actions. Finally, the Motion states the Plaintiff will suffer no hardship if a stay is granted. A copy of this Motion was forwarded to both the Appellant and the Intervenor. A response was received from the Intervenor only objecting to the Motion to Stay. Intervenor believes none of the circumstances alleged by the Respondent demonstrate good cause.

Recommendation: Deny Motion to Stay and grant BOR a Final 30-day extension.

oo. Stagg III: #09-34239-I-3 (Cook – Hanover)

This appeal was made “ready hearing” and complete on 4-9-13. The PTAB had no record of evidence being received by the Cook County Board of Review and a default letter was issued on the same day. The BOR has since sent in Notes on Appeal with evidence to the PTAB that contain a stamp, not belonging to the PTAB, dated 9-13-12. The BOR alleges they stamp their own evidence on the day it is mailed to our office. The BOR is requesting the PTAB vacate the default order and accept the evidence. The Intervenor has filed evidence in this file.

Recommendation: Deny request to vacate the default. The PTAB has no record of receiving the purported evidence from the BOR.

pp. MM Industrial Lies Road, LLC: #11-01975-I-3 (DuPage)

Intervenor, C.C.S.D. #93, originally filed with PTAB on 3-21-13. A total of 120-days has been granted for the submission of evidence with the latest extension expiring 7-10-13. No correspondence was received from the Intervenor after this date and C.C.S.D. #93 was defaulted on 7-24-13. Per Motion received 7-22-13, Intervenor submits a 30-day extension request and cites a clerical error and a lead attorney for the Intervenor as being out of the country as reasons for tardiness. Motion is requesting the PTAB allow default to be vacated and the 30-day extension request granted.

Recommendation: Deny request to vacate default.

qq. One Earth Energy LLC: #11-00742-I-3 (Ford)

Appellant originally filed with PTAB on 2-20-12. A total of 90-days has been granted for the submission of evidence. Appellant is requesting a 90-day extension until after the final resolution of the 2009 year appeal, which is presently set for hearing with PTAB on 11-4-13. Appellant states there is a pending real property versus personal property classification issue which, resolved by the PTAB in the 2009 appeal, will dictate the evidence to be offered, including the appraisal evidence, by each party for the 2011 appeal. Appellant asserts there are significant costs involved that may be avoided once the 2009 decision has been issued and the PTAB decision may allow the parties to settle subsequent year appeals.

Recommendation: Grant an extension until 90-days after the resolution of the 2009 appeal (which will include administrative review).
