## CITRUS COUNTY WILLS

Wills - A most important document in both life and death.

Making a will assures you that the persons you leave behind are taken care of in the manner that you want for them. Making a will assures that they will get what is coming to them - be it good or bad.

When you leave all of your possessions to Aunt Edith and nothing to Uncle George, a will sees to it that the court makes sure that Aunt Edith gets what she is supposed to get.

A will can be a peace making document or a revengeful document. Either way it gives the maker peace of mind.

The Will Books of Citrus County are eight in number. Some are cloth bound and some are leather bound. Books One and Two are hand written. Books three through eight are typed. These books contain not the original wills but copied documents done by the clerk of court of that time.
