## A Large C lass of N ew G ravitational and A xionic Backgrounds for Four-dim ensional Superstrings

#### ABSTRACT

A large class of new 4-D superstring vacua with non-trivial/singular geom etries, spacetim e supersymm etry and other background elds (axion, dilaton) are found. K illing symm etries are generic and are associated with non-trivial dilaton and antisymm etric tensor elds. Duality symmetries preserving N = 2superconform al invariance are employed to generate a large class of explicit metrics for non-compact 4-D C alabi-Y au manifolds with K illing symmetries. W e comment on som e of our solutions which have interesting singularity properties and cosm ological interpretation.

## 1 Introduction

String theory is a promising candidate for a theory unifying all the fundamental interactions, including quantum gravity. Gauge and dieomorphism symmetries appear naturally and the theory has very smooth ultraviolet behavior. However, the theory is still conceptually incomplete, in the sense that, a background independent string eld theory, where the full string symmetry is manifest, is not at hand. In particular, we have no way, so far, to understand non-perturbative elects (except in some toy bosonic models in 2-D, [1]). The only way we know, up to now, to deal with the theory, is in the rst quantized perturbative framework, where one starts with a classical solution to the theory, which is given by any CFT with the appropriate central charge. One then calculates in string perturbation theory the S-matrix of uctuations around that classical solution. In particular, it is known that, unless the spacetime physics is at least N = supersymmetric, then the initial perturbative vacuum is in general unstable and therefore perturbation theory around it is ill de ned. Thus, in perturbation theory, only classical solutions with at least N = spacetime supersymmetry are guaranteed to be stable.

There are some extra problems in order to connect superstring theory predictions at low energy to the observed world. The rst is that there is always a scalar excitation in the theory, the dilaton, which is massless to all orders in perturbation theory. There are good reasons to believe that such a massless scalar does not exists in our world. The second is that, at low energy, there is no supersymmetry in the observed spectrum of particles. In fact, the breaking of space-time supersymmetry in string theory was extensively discussed in the past, where essentially two kinds of mechanisms were considered: the \perturbative" breaking via the Scherk-Schwarz mechanism [2] and non-perturbative supersymmetry breaking by gaugino condensation at the level of the string elective eld theory [3]. However, unless we have a good string eld theory which is background independent, there is little chance that we will have a fundamental understanding of the resolution of the two previous problem s.

However, there are still some important conceptual questions one can ask in string theory. So far, in eld theory there is not even a consistent perturbative fram ework, in order to address questions concerning quantum gravity. On the other hand, string theory provides also a theory of quantum gravity without ultraviolet problem s. Even in the present limited form ulations of string theory, there is still room to address questions which have perplexed physicists in the past decades concerning in particular issues like set-up of scattering theory in curved spacetimes, black holes, Hawking radiation etc.

Several e orts focused towards this direction in the recent past. One expects that the physics of gravitation at short distances, as described by string theory, would be radically di erent from that at large distances and scales. The probes here are entities (strings) with non-zero size, and there are quantitative indications that the concept of classical metric is not good enough to describe even qualitatively the physics at regions of spacetim e which are strongly curved [4, 5]. Such indications com e from the existence of duality symmetries in many non-trivial classical solutions of string theory (where the m etric, dilaton and other background elds are non-trivial functions of coordinates). These symmetries imply that the background elds by them selves do not uniquely describe the ground state, but stringy probes, excited in dierent states, \see" dierent background elds.

In this work, we will address a speci c aspect of these problems, namely, we will try to analyse as exhaustively as possible, 4-d string solutions which have the following properties: The metric and other background elds are non-trivial, and the solutions are perturbatively stable, equivalently, they have spacetime supersymmetry. In the context of the type II superstring, this translates to the statement that the worldsheet CFT has (2,2) superconform al invariance (in which case the spacetime theory in 4-D has N = 2 supersymmetry) [6,7]. V is the heterotic string map [8,7], such type II solutions generate a class of heterotic string models with N = 1 space time supersymmetry.

During recent years, several e orts were focused on N = 2 superconform al backgrounds in the context of (heterotic) string compactications leading to strings with at four-dimensional space time [9, 8, 7]. In these works the discussion mainly focussed on compact spaces without torsion and with constant dilaton eld, i.e. tori, orbifolds, the  $K_3$  manifold and num erous Calabi-Yau spaces.

In this paper we will provide a relatively system atic discussion on supersymmetric string backgrounds with N = 2 or N = 4 superconform al symmetry, based on com pact as well as non-com pact spaces plus non-trivial antisym m etric tensor- eld and nonconstant dilaton. Thus we will extend in a more system atic way the exact N = 4 solution constructed recently, [10, 11]. In the case of vanishing antisymmetric tensor elds the m etric is known to describe a com pact/non-com pact K ahler space [12]. In order to introduce non-constant antisymmetric tensor elds, we have to use a 2-d superspace action, which includes chiral as well as twisted chiral super elds [13]. In contrast to the com pact Calabi-Yau spaces, alm ost all backgrounds with non-trivial dilaton eld will possess Killing symmetries. Our main focus will be such backgrounds with isometries which turn out to be generic in 4-D (rem em ber that in 2-D all string backgrounds have killing symmetries). In addition, most of such backgrounds exhibit singularities on some hypersurface in spacetime. These spaces, which can be regarded as generalizations of the two-dimensionalblack-hole considered in [14], provide gravitational instantons, black-hole type backgrounds, worm -holes and cosm ological solutions in four and higher dimensions [15, 10, 16, 5, 11, 17].

A key to the proper understanding of string propagation on curved spaces is provided by duality symmetries. As mentioned above, duality symmetries relate backgrounds which are geometrically or even topologically dierent [18] but nevertheless correspond to the same superconformal eld theory (there is a non-local transformation in the model variables that maps the -model to its dual [4]). For example, a singular space can be dual to non-singular space, as rst shown for the Euclidean two-dimensional black-hole [19, 17, 20]. A lthough it is not known in general, what are all dual equivalent backgrounds starting from a given background, the construction of the dual spaces is straightforward if the original space possesses som e isom etries [21, 22, 23] (although this is not necessary, [4, 20]). For the cases with extended world-sheet supersymmetries it was shown [24, 13] that the duality symmetry originating from a U(1) isometry can be understood as replacing chiral (twisted chiral) super elds by twisted chiral (chiral) super elds by a Legendre transformation. This duality transformation preserves the N = 2 superconformal invariance of the theory. Some interesting examples of dual backgrounds were already constructed this way [25].

The structure of this paper is as follows. In the next chapter we will set up the N = 2 (N = 4) supersymmetric -model using chiral and twisted chiral super eds. We end this section with the construction the dual spaces assuming that the original space has some U (1) isometries. Section three deals with the Kahlerian solutions of the string eld equations. For non-trivial dilaton eld the spaces are in general non R icci- at and possess K illing symmetries (isometries). We also construct the corresponding dual spaces which are in general non-Kahlerian. In section four we consider solutions which from the beginning possess torsion and are therefore non-Kahlerian. Performing a duality transformation we obtain additional new classes of Kahlerian spaces where many of them are R icci- at. Section ve discusses some aspects of S duality [26] pertinent to some of our solutions. Finally section six contains our conclusions and further remarks. In the appendix we discuss some constructions and further remarks. In the appendix we discuss some constraints for the superpotential which are of direct interest to N = 2 LG models [27], with non-trivial metrics.

D uring the paper, we will mainly focus on four-dimensional spaces which appear to have most physical relevance.

# 2 The N = 2 (N = 4) Background and U(1) Duality Transform ations

#### 2.1 The N = 2 supersymmetric 2-d action

The most general N = 2 superspace action form chiral super eds  $U_i$  (i = 1;:::;m) and n twisted chiral super eds  $V_p$  (p = 1;:::;n) in two dimensions is determined by a single real function K ( $U_i$ ; $U_i$ ; $V_p$ ; $V_p$ ):

To see the background interpretation of the theory it is convenient to write down the purely bosonic part of the superspace action (2.1.1):

Here  $u_i$  is the lowest component of the super eld  $U_i$  and so on. Thus, one recognizes that the rst two terms in above equation describe the metric background of the model where the metric in complex coordinates has the following block-diagonal structure:

To obtain a space with Euclidean signature, one has to require that  $K_{u_iu_j}$  is positive de nite where  $K_{v_pv_q}$  has to be negative de nite. Note that the metric (2.1.6) is not Kahler, whereas the action (2.1.1) is nevertheless N = 2 supersymmetric. If there are only chiral resp. twisted chiral elds (i.e. m = 0 or n = 0) one deals with a Kahler metric.

The ab-term in (2.1.4) provides the antisymmetric tensor eld background:

So far we have just discussed the geom etrical structure of the N = 2 backgrounds. In order that these backgrounds provide consistent string solutions, they have to satisfy the string equation of motion, i.e. the vanishing of the -function equations. In string theory, there is another background eld, the dilaton  $(u_i;u_i;v_p;v_p)$ , which accompanies in generalG and B. This amounts to add to the -m odel action eq. (2.1.4) a term of the form  $\frac{1}{2}R^{(2)}$   $(u_i;v_p)$ , where  $R^{(2)}$  is the scalar curvature of the two-dimensional world-sheet. Then the requirement of one-loop conform al invariance of the two-dimensional -m odel leads to the following equations of motion for the background elds, [28]

W e m ust emphasize here that in the presence of N = 4 superconform al symmetry the solution to the lowest order in ' is exact to allorders in a speci c scheme, and c remains zero to all orders.

#### 2.2 U(1) duality transform ations

Let us assume that a particular background, which satis es eqs. (2.1.10) and (2.1.11) at low est order in <sup>0</sup>, really corresponds to an exact conform all eld theory. Then there exist in m any cases di erent, so called dual, backgrounds which how ever are truly equivalent as a conform all eld theory. In particular, if the original background is independent from d (real) coordinates <sub>a</sub> (a = 1;:::;d), i.e. if the original background possesses an Abelian U  $(1)^d$  isom etry, there exist dual but equivalent backgrounds which are obtained from each other by discrete O (d;d;Z) transform ations [23]. (M oreover the eld equations (2.1.10) and (2.1.11) are invariant under continuous O (d;d;R) transform ations [22]. U sing the continuous transform ations one can generate classes of backgrounds which correspond to m arginally deform ed conform all eld theories [4, 30].)

Let us consider the most simple case of a single U (1) isometry assuming that the potential K has one K illing symmetry and is of the form

where Z and  $Y_i$  are chiral eds, whereas  $V_p$  are twisted chiral eds. (Of course the discussion holds in the same way if Z is a twisted chiral ed.)

In [24, 13] a duality transform ation was described in which twisted super elds are interchanged with untwisted ones. Concretely, assume the existence of one U (1) K illing symmetry, R = Z + Z, and consider the 'dual' potential

In [31] it was shown that this N = 2 duality transform ation via Legendre transform is the same as the usual abelian duality transform ation [21]. This connection is im portant because one can compute also the \quantum corrections" to this classical duality transform ation, which am ount to a non-trivial dilaton. We will discuss explicitly this connection, since the discussion in [31] was not su ciently general.

In sum mary, the  $Z_2$  duality transform ation can be expressed by a Legendre transform ation in the superspace action which replaces a chiral super eld by a twisted chiral super eld. W e will use this observation in the following chapters to generate N = 2 supersymmetric backgrounds with torsion from torsion-free Kahler spaces. Moreover we will also demonstrate that backgrounds with torsion have as dual counterpart very interesting Kahler spaces with isometries which are Ricci- at but non-compact.

## 3 Kahler Spaces without Torsion and their Dual

### 3.1 Kahlerian backgrounds

It is already well known that if the torsion vanishes and there is no dilaton eld the condition that a -m odel has N = 2 supersymmetry is that the target space is K ahler, [12]. If a non trivial dilaton is present but no superpotential then there are no additional restrictions. It is interesting though that if a superpotential is present then there are non-trivial constraints to be satis ed. Such constraints have the interpretation that there there exist appropriate screening charges (always required when a non-trivial dilaton is present) which preserve the N = 2 superconform al invariance. W e will return to this in the A ppendix since it is of direct relevance to generalizations of LG m odels with non-trivial dilaton.

For the time being we start with a Kahler manifold specied (locally) by its Kahler potential K  $(u_i;u_i)$  and a dilaton eld. The metric is given in terms of the Kahler potential by the standard formula

In such a case the Riemann tensor is self-dual and therefore the space is Ricci-at. Ricci atness and c = 0 implies constant dilaton. However, we note that the hyper-Kahler condition is not the only way to obtain c = 0; in fact we will provide N = 4 examples which are non-Ricci-at and have non-constant dilaton eld. These examples will be presented later.

Let us see how far we can go in solving the conditions for conformal invariance (3.1.4,3.1.5). The holom orphic double derivative equations on the dilaton can be written (after raising one index) as

Performing an analytic continuation from the Euclidean to M inkowski space-time, one deals with the two-dimensional black-hole for (ii), but with a cosm ological scenario for (iii).

Obviously, four-dimensional backgrounds with N = 2 supersymmetry are obtained by building all possible tensor products [11] of the two-dimensional cases listed just before. This gives 21 possibilities where, however, several cases are equivalent since they are the dual of each other. In addition it is interesting to note that if one couples the cosm ological space (ii), based on the coset  $\frac{SU(2)}{U(1)}$  with level k<sub>1</sub>, to any other two-dimensional solution with level k<sub>2</sub>, then the resulting central charge defect vanishes, i.e. c = 0 provided if k<sub>1</sub> = k<sub>2</sub>. (In the corresponding coset conform all edd theories, the level must be related like k<sub>2</sub>  $k_1 = 4$  for SU (2)=U (1)<sub>k<sub>1</sub></sub> SU (2;R)=U (1)<sub>k<sub>2</sub></sub>.) In fact these types of product spaces lead to an enhanced N = 4 world-sheet supersymmetry. The corresponding N = 4 superconform all algebras were explicitly constructed in ref. [11].

Let us now consider four-dimensional backgrounds which are not direct products of two-dimensional spaces. Speci cally we consider solutions of the form eq. Since this string solution has two abelian killing symmetries we can use O(2,2R) transform ations to generate a family of solutions. However, a priori O(2,2R) transform ations may break the N = 2 superconform all invariance. Identifying in general such an N = 2 subgroup is a di cult problem and we will not attempt it here. We will indicate how ever a subgroup that always preserves N = 2. This is generated by the abelian duality transform ations described in section 2.2 and constant antisymmetric tensor shifts (in general gauge transform ations of B that leave H invariant, i.e. B ! B + @ @ ). A belian duality transform ations of B ) also preserve N = 2 supersymmetry since the extra term s in the action are total derivatives (although they change the spectrum in general).

B gauge transform ations are generated (in the case where H  $\notin$  0) by the quasi-K ahler transform ations (2.1.3). These can be intertwined with the U (1) duality transform ations to generate non-trivial orbits of solutions since B-gauge transform ations and U (1) duality do not commute.

Not all such B-shifts can be done in an N=2 invariant language, (for example a constant B-shift in the Kahler case). It is an interesting problem to describe all duality

transform ations which contain B gauge transform ations in a manifestly N = 2 invariant fashion.

Thus, the generic duality group (subgroup of O (d,d)) which preserves N = 2 is generated by the d Z<sub>2</sub> duality transform ations D<sub>i</sub> and constant B-shifts (in K illing coordinates). The D<sub>i</sub> act as the O (d,d) m atrices

Having found explicit K ahlerian backgrounds which solve the string equations of motion we can now construct their dual spaces replacing one chiral eld u by a twisted chiral eld . It is not di cult to show that this is exactly the metric of the so called sem i worm hole space [10, 5, 11]. (The inverse duality was rst discovered in [25].) It corresponds to the exact conform allel theory, based on the W ZW model SU (2) U (1). So after a suitable projection in the H ilbert space, the conform allel theory, based on SU (2)=U (1) U (1)<sup>2</sup> becomes equivalent to SU (2) U (1) conform allel theory [11]. It is not dicult to show that the torsion which arises after the duality transform ation is just given by the structure constants of SU (2).

## 4 Non-Kahlerian Spaces with Torsion

#### 4.1 Four-dim ensional non-Kahlerian spaces

To start with non-vanishing antisymmetric tensor elds we restrict ourselves to the sim – plest case, namely to four-dimensional target-spaces, i.e. m = n = 1. Then, de ning  $U = \log K_{uu}$  and  $V = \log K_{vv}$ , the Ricci-tensor becomes

So far we have considered the conditions on the backgrounds which are imposed by N = 2 supersymmetry. For a background to lead to enhanced N = 4 supersymmetry one expects that non-renormalization theorems [32] are valid. These imply that c = 0. When the dilaton is zero the condition for N = 4 supersymmetry was derived in [13] and it states that the quasi-K ahler potential has to satisfy the at Laplace equation. This is precisely case (i), eq. (4.1.8), after a trivial rescaling of the coordinates:

Therefore, in the Einstein frame, the nontrivial backgrounds with N = 4 symmetry are entirely given by non-trivial dilaton and axion eld con gurations. In fact, the solutions of the dilaton equation (4.1.23) have a very close relation to the axionic instantons of [16]. Speci cally from eq. (4.1.23) we get for example that  $H_{uuv} = K_{uuv} = 2e^2 Q_v$ . Thus, equation (4.1.23) in plies the following relation:

This relation is nothing else than the self-duality condition on the dilaton-axion eld. Its solutions are called axionic instantons. However note that an instanton con guration which provides a solution of eq. (4.1.25) does not necessarily solves the Laplace equation (4.1.22). Therefore not any axionic instanton solution is expected to be N = 4 supersymmetric.

The form of the solutions of the Laplace equation depends on the num ber of isom etries of the theory. For the case with two translational U (1) K illing sym m etries, i.e. K = K (u + u; v + v) the most general solution of (4.1.22) looks like

#### 4.2 Dual, Kahlerian space which are Ricci at

Let us now construct the dual spaces for the solutions of the Laplace equation with one or two isom etries, (4.1.26, 4.1.27). We will perform a duality transform ation on the chiral U - eld replacing it by a twisted chiral eld . The Legendre transform ed potential K will only contain twisted elds and will be therefore a true K ahler function leading to a non-com pact K ahler space without torsion.

The interpretation of the metric (4.2.4) is as follows: The G dvdv part describes the metric of a 2-d R iem ann surface (generically non-compact). The metric depends also on z + z. For xed z + z,  $A_v$ ;  $A_v$  describe a at line bundle on the R iem ann surface. The metric (4.2.4) is that of a at complex line bundle on the R iem ann surface. The functions G,  $A_v$ ;  $A_v$  are harm onic.

The metric (4.2.4) describes a large class of 4-d non-compact Calabi-Yau manifolds, which are also hyper-Kahler. The associated -m odels have N = 4 superconform al sym -m etry and c = 6 (c = 2). The manifolds have generically asymptotically at regions as well as curvature singularities.

where T (z) is an arbitrary m erom orphic function. It is crucial to note that the m etric (4.2.10) is not written in Kahler coordinates. Such coordinates are v;v and w;w with  $w + w = iT^{0}(r_{1} + ir_{2})$   $iT^{0}(r_{1} - ir_{2})$  and w w = 2i.

Now the interpretation of the metric (4.2.10) is straightforward: If we take ; to be angular variables, then they parametrize a 2-d torus, with modulus T (z) which depends holom orphically on the rest of the coordinates and conform al factor proportional to 1=Im T. The zeros and poles of the R iem ann tensor are determined by the zeros and poles (or essential singularities) of the function T (z).

This solution (with a di erent interpretation) was found in [33], where some global issues were also addressed<sup>z</sup>. We should note that as in [33] a full invariance under the torus modular group, T ! T + 1 and T ! 1=T can be implemented by a holom orphic coordinate transformation in z, which will modify Im T to a modular invariant in the rst part of (4.2.10). It was also argued that such a metric might receive higher order corrections. However we have just shown that this metric is the dual of the family of worm hole solutions which are absolutely stable as CFT s due to their N = 4 superconform al symmetry and it does possess a hyper-K ahler structure although not easily visible in this coordinate system.

The 4-d non-com pact CY manifolds presented in this section constitute a large class of exact solutions to superstring theory with extended supersymmetry. A detailed analysis of their structure as well as their M inkow ski continuations is beyond the scope of this work and is reserved for future study.

## 5 S D uality and the A xion

In 4-d we can trade the antisymmetric tensor B for a scalar eld b, the axion. The -function equation for B imply that we can write

At higher orders the SL(2;R) symmetry is broken down to SL(2;Z) known as the S-duality symmetry.

An inportant question is: does S-duality preserves spacetime supersymmetries? To answer the question in the armative, we need to observe that spacetime fermions transform hom ogeneously, as forms, under S-duality. In particular, S-duality transformations of the D irac operators (whose zero mode spectrum determine the number of unbroken supersymmetries) correspond to gauge transformations. Thus, they do not a ect the zero mode spectrum and consequently the number of unbroken supersymmetries. If the worldsheet theory has N = 4 superconformal symmetry then the 1-loop equations have no higher order corrections. Then S-duality generates exact N = 4 backgrounds.

W e will study separately the action of S-duality on solutions to the -function equations corresponding to cases (i,i,i,iii) in section 4.1.

(i) The N = 4 solutions found in section 4.1 translate as follows in our new variables,

S-duality is a symmetry of the string e ective action in 4-d and its status is obscure although some progress has been made towards elucidating its implications for string

theory (see for example [26] and references therein). In particular a worldsheet understanding of the symmetry is lacking. It is our opinion that class (i) of string solutions is a very useful ground to study the implications of S-duality, due to their high symmetry (N = 4) and the fact that they are exact solutions to string theory.

(ii) In this case the quasi-K ahler potential satis es (4.1.12). The solutions found in this class are the N = 2 preserving O (2,2,R) transform s of the K ahler solutions in section 3. In order to have c = 0 we must set the constant q in (4.1.12) to zero (If at higher orders,  $c \in 0$  then S-duality will not produce new solutions). The E instein m etric here is not at

A cting on (5.10) with SL (2Z) transform ations generates new solutions.

In case (iii) the elds s cannot be written explicitly as functions of the Kahler potential, so we can not proceed further.

For K ahlerian backgrounds (H = 0) the only S-duality transform ation which stays in this class, changes the sigh of the dilaton (inverts the string coupling).

A nother set of new solutions can be obtained from the tensor product theory  $\frac{SU(2)_k}{U(1)}$  $\frac{SL(2R)_{k+4}}{U(1)}$  [11] by applying S-duality, but we will not delve further into this.

## 6 Conclusions

We have examined some four-dimensional superconform all theories with N = 2 and N = 4 superconform allows metry (classical solutions to superstring theory). We show that there exists a plethora of such theories with non-trivial metric, dilaton and antisymmetric tensor eld.

Our solutions are classied in two classes:

(i) Those that are based on a Kahler manifold (when H = 0).

(ii) The non-Kahlerian solutions with non-zero torsion.

These two subclasses are related by  $Z_2$  duality transform ations (when isom etries are present).  $Z_2$  duality interchanges the roles of untwisted and twisted chiral super elds and act in a manifest N = 2 preserving fashion. There is a generic subgroup of O (d;d;Z) duality and a corresponding subgroup of its conform all deform ation partner, O (d;d;R), which are shown to preserve the extended superconform all invariance (N = 2A). They are used to obtain a more general class of solutions where a super eld form ulation is not

manifest. It is an interesting problem to form ulate the N = 2 preserving O (d,d) action in a manifestly N = 2 supersymmetric form.

Another way of enlarging the class of solutions is via S-duality, which is a symmetry when c = 0, as it happens in the presence of N = 4 symmetry.

In the K ahlerian case we show that the presence of a non-trivial dilaton eld im plies the presence of an isom etry in the background data (K ahler m etric and dilaton). The current associated to this isom etry is the bosonic part of the N = 2 U (1) current (its presence is due to the non-trivial dilaton). A non-trivial dilaton im plies also a di erent LG hypersurface constraint which generalizes the vanishing of the superpotential in the constant dilaton case. It is interesting that we obtain these m odi cations from the requirem ent of consistently coupling the -m odel to N = 2 supergravity. In particular the constraints above com e directly from the scalar constraint associated to the auxiliary eld of the N = 2 supergravity multiplet. Am ong the K ahlerian solutions we mean a large class of (non-com pact) R icci- at (CY) manifolds with one isom etry. This class of solutions generalizes the com pact 4-d R icci at manifolds (K 3). A special case of the solutions above (with two isom etries) is that of ref. [33] found in a slightly di erent context. These CY manifolds are duals of non-zero torsion solutions with N = 4 symmetry.

The N = 2A solutions with non-zero torsion are classified in terms of zero one and two isometries in the special (quasi-Kahler) coordinate system. We have derived also their Kahlerian duals.

The Hyper-K ahler solutions we nd have non-trivial metric in the E instein frame. On the contrary, the N = 4 solutions with non-zero torsion have always a at E instein metric and some of them (those with two isometries) give all the possible supersymmetric axion-dilaton instantons.

It is also observed that, contrary to expectations, isom etries are generic in 4-d supersym m etric string backgrounds.

U pon analytic continuation of the Euclidean solutions we have found we can obtain m any cosm ological solutions to superstring theory whose spacetime properties deserve further study.

Scalar C onstraint in N = 2 d = 2 Supergravity and its equivalence to G eneralized N = 2 L-G Equations.

In this appendix we will show that the (2,0) and (0,2) -function equations (3.1.3,3.1.5) of an N = 2 superconform all system, follows from a classical scalar constraint due to the auxiliary eld of the N = 2 supergravity multiplet, in the presence of a non trivial dilaton background R<sup>(2)</sup> and non zero chiral deform ation <sup>R</sup>W(<sub>i</sub>). Also we will show how the non trivial dilaton background implies the existence of an isometry in the metric, and how the N = 2 LG equation (w(<sub>i</sub>) = 0) are generalized in the presence of non trivial dilaton<sup>{</sup>

First we would like to extend the R  $^{(2)}$  dilaton background to a generalized N = 2 one, where the other components of the gravitational supermultiplet explicitly appear. The most general coupling among the chiral elds  $\hat{i}$  and  $\hat{i}$  is given in terms of a general K ahler function G (i; i; i; i) and a general superpotential W (i; i) as usual (see section 2.1). In our case both the functional form of G and W are restricted and this is because the  $\hat{i}$  eld has to de ne correctly the background m etric and the background gauge eld of the supergravity multiplet as in the above equations; e.g.  $e^{(+)}$  is the

W e are now in a position to exam ine the algebraic equations which follows after the elimination of the auxiliary elds H and  $F_i$ . Setting the ferm ions to zero the relevant part of the N = 2 lagragian reads

Thus, we see that the consistent coupling of an N = 2 - m odel to N = 2 supergravity in plies at the classical level the (2,0) and (0,2) -function equations, which as shown in section 3.1 in ply in turn the existence of a killing sym m etry in the K ahler potential. The interpretation of this is as follows. If the dilaton is constant, the N = 2 U (1) current is purely ferm ionic and conserved at the classical level. W hen the dilaton is non-trivial, then the N = 2 U (1) current acquires a bosonic contribution ( $J^A$ ). In order for it to continue to be conserved, a killing sym m etry of the K ahler m anifold is necessary.

As we have explained above (A.14) in plies the classical scalar constraint
