

Gentlemen:

Enclosed herewith is letter received today from Borderland Sciences Research Associates that I am sending to you for examination. It was mailed from "York, 1808 Jefferson, K.C., Mo."

Everything concerning the "Associates" may be above board but I am a little suspicious in these days and times. First, I note that the letter head says Wayne, A.M." and the signature says Wayne, M.A." Second, Webster's International Dictionary does not list "F.H.F." appearing at the end of the directors' names as being a known degree or title.

I am a Construction Engineer with the U. S. Bureau of Reclamation, have been a licensed amateur radio operator for nearly 30 years and am a Director of the American Radio Relay League. It is only natural that I am interested in reading articles or booklets concerning the subjects referred to in the letter. But I am not able to reason out why the "Associates" are particularly interested in getting members from among the "Division Directors and Section Communications Managers of the American Radio Relay League" unless they are interested in communications during periods when an enemy would disrupt our usual communication system. Basically, this might be a good idea, but it would make a lot of difference with whom we communicated.

I know nothing whatever about the directors of the organization or its writers of booklets and I have no interest whatever in joining any group which is considered now or ever could be classed as slightly tainted. However, if the organization is above board, as evidenced by your files, I am sufficiently curious to find out what it has to offer.

There is attached for your information and the information of agencies receiving a copy of this communication a Photostat of literature published by the Borderland Sciences Research Associates, 3524 Adams Avenue, San Diego, California.

Mr. Francis Ohm, Businessmen's Assurance Company, San Diego, California, advised on August 1, 1952, that he was a member of the Borderland Sciences Research Associates and claimed that through the techniques referred to in the attached literature, the organization was able to predict in advance the recent earthquake which occurred in Tehachapi, California. In addition, Mr. Ohm stated that they have been able to obtain the following information:

1. That a very severe tidal wave will hit the Pacific Ocean sometime in the not too remote future and that most of the Japanese Islands will be washed away and disappear.

2. That all fishes with scales in Japanese waters will soon leave these waters for other destinations, in view of the oncoming tidal wave.

In view of the current hysteria concerning the so-called "flying saucers", I thought that the Bureau might be interested in the following information concerning the captioned organization.

I am transmitting herewith certain literature concerning the captioned organization which was furnished to me by FRANCIS OHM, who operates the Businessmens Assurance Company in San Diego and who has his office in the same building housing the FBI office.

It is of interest to note that on Friday, August 1, 1952, at approximately 12:00 noon, FRANCIS OHM asked to see me urgently, which I did. Mr. OHM requested that either I myself attend the meeting at 1:00 PM or that I designate a stenographer to attend the meeting, so that she could take down all the minutes of the meeting. I told him that unfortunately this was very short notice, that I had another commitment and that our stenographers were pretty well occupied at that time. He said he would advise me of anything important that might transpire at the meeting. As of August 2, 1952, he has not advised me of anything which transpired at the meeting.

I should like to point out that OHM appears to be a perfectly sane, sound individual; he operates a very large insurance business in San Diego, and is convinced in his own mind of the efficacy of this organization.

No investigation is being conducted concerning this matter and I do not contemplate attending any meetings of this organization.

BSRA 1. THE MORLEY-MARTIN EXPERIMENTS - and - THE EXPERIMENTS OF DR. CHARLES W. LITTLEFIELD. "The account of these experiments was printed in Flying Roll (now discontinued) Alpha III and Beta III, 1948. Second printing July 1950. The experiments of Dr. Littlefield are detailed in his book "Man, Minerals, and Masters ("M-M-M"); their purpose is to show that "thoughts are things" - and that mind-energy can be brought to bear upon microscopic crystals of organic salts, and will modify their formation upon the microscope slide where the process can be clearly observed, and the results photographed. The evidence presented appears conclusive, and is certainly in line with later experiments with the "PK" effect. It was Dr. Littlefield's practise to formulate the "mind energy" by the use of mantrams, which the microscopic crystals re-expressed in symbolic forms. The author's pre-occupation with occult studies has probably prevented scientific recognition, nevertheless it should be possible to repeat, verify and extend the experiments indefinitely. The BSRA Booklet 1 contains a seven-page resume' of these experiments.

The remaining 14 pages contain (1) A translation of Maeterlinck's account of Morley-Martin's work, as set out in his La Grande Porte (Paris, 1939); (2) - The comments of Professor C. J. Ryan on the M-M experiments, as published in the Theosophical Path in 1935; (3) The experiments of Andrew Crosse, under the head "Animal Life by Electricity". (4) The article on the same subject by Lieut. Com. R.E. Gould, in his book called "Oddities" (1928); (5) A generalized comment on the whole subject by the trance Control Natali (Mark Probert seances) The nature of this remarkable material may be gathered from the following excerpts:

... 'That plants and animals continue to live in miniature and in a latent state in the rocks which geologists call azoic, millions of years old, in which no traces of organism have been found . . . that life is immortal, universal and indestructible, and that the mother-idea, the image or prototype of everything, is anterior to what we call matter... He took azoic rock or a bit of glass and sterilized it at 3000 deg. F., reducing it to a light ash containing scoria... From these ashes he isolated a "primordial protoplasm", which after passing thru a crystalline stage gave birth to organic life forms - altho the conditions of sterilization were perfect, the tests often repeated, and observed by competent witnesses' (Maeterlinck). "The animal loses its body" (writes Morley-Martin) but does not lose its life,... Nothing dies ... the contrary of life is not death, but latency." "The most extraordinary discovery that science will have to record since Newton's gravitation and the discovery of radium." (Maeterlinck).

The experiments of Andrew Crosse, detailed in BSRA 1, show the production of living organic forms (acari, or mites) out of highly poisonous solutions, when these were subjected to certain electrical treatments.

The work of Morley-Martin, Littlefield, and Crosse, together with related experiments by Weeks, Bastian, and Twining, constitute the most remarkable collection of biological, or psycho-biological data in modern science; its import is revolutionary and affects not only all the biological sciences but philosophy and metaphysics as well - yet it has been studiously ignored by contemporary scientists and philosophers alike.

So far as is known to us, the 21 pages of BSR booklet 1 contain the only existing synopsis of this material - which as a matter of factual information should be familiar to all Associates of the Borderland Sciences.

BSRA 3. THE KOCH TREATMENT FOR CANCER & ALLIED ALLERGIES. This is a 25-page mimeo, reprint of an article appearing in BSRA "ROUND ROBIN", and gives a sketch of the history and present status of the Koch treatment. In spite of the long continued and vicious opposition of the American Medical Association, this treatment continues to gain ground - and with increasing rapidity. According to present information, more than 4000 physicians in the United States are now using it - with an estimated 80% success. In addition to cancer, the diseases successfully treated with the Koch catalyst include asthma, hay fever, eczema, arthritis, other rheumatic diseases, undulant fever, San Joaquin fever, malaria, rheumatic fever, infantile paralysis, sinusitis, tonsillitis, bronchitis, kidney disease, liver and gall bladder diseases, peptic ulcer, coronary heart disease, goitre, and prostatic diseases.

As to the motives inspiring the utterly unprincipled opposition to the Koch treatment, it is perhaps sufficient to point out, that it costs about \$6000 to die of cancer in the United States (old figures - probably \$10,000 now), and that there are about a million current cases - none of which are curable by surgery, Radium, or X-rays - the only methods approved by the AMA. The product of 6000 x 1,000,000, or 6000 million dollars, is a very substantial backlog for the Medical profession, and not likely to be sacrificed even on behalf of human suffering and death. There are, in fact, several highly successful cancer treatments, ALL of which are bitterly opposed by organized medicine, but BSR Hqrs. is interested in the Koch method particularly, partly because it has been under observation (and attack) for some 25 years past, and has steadily gained ground, not only in the U. S., but throughout the world.

The laboratories and general Hqrs. of the Koch treatment are: Christian Medical Research League, 14350 East Jefferson, Detroit 15, Mich. Names of physicians in any given locality, using the Koch treatment, can usually be obtained from them. No general or national lists are furnished. Lists at BSRA Hqrs. are brief and refer for the most part to physicians on the Pacific Coast. The book BIRTH OF A SCIENCE is published by DEFENDERS, INC., Wichita, Kansas - more than 400 pages, at \$1.00 (less than cost). Do not order "Birth of a Science" from BSRA Hqrs. We have only the mimeo, booklet BSRA 3 (p. "A" of this folder), at \$1.00 - and a 50¢ booklet, 25 pp., THE KOCH TRIAL, by A. Fitz Roy Anderson.

The BSRA take an interest in this for humanitarian reasons, as a public service, and in protest against the viciousness of organized medicine and other entrenched interests. We recommend that all Associates inform themselves on this matter, come to their own conclusions, and then aid in giving the information to others.

A 15-page mimeo booklet containing (1) Data assembled by Brian Brown, in his "Dynamic Power of the Inner Mind" (2) Comments of Assoc. E. K. KRIEGER - reprint from Round Robin (3) Psychic investigation of VITIC (4) Comments of Nandor Fodor on Reichenback (5) Miscellaneous material. Compiled for informational purposes only, with no attempt to argue any thesis pro or contra the alleged therapeutic effects. (But experiments with the galvanometer indicate that something resembling "nervous" or electrical energy is stored in the nerve ganglia by contact with carbon and the permanent magnet). So far as known to us, this is the only existing compilation of data on this remarkable effect.

There is probably nothing in the history of psychism more remarkable, and better attested, than the phenomena of Kluski and Mirabelli. Both mediums belong to the turn of the century, down to a fairly recent date.

"We exclude nothing that has any basis in fact", writes Associate Hilliard, "and likewise study every concept and theory for possible clues and angles. We do not say any phenomenon is absurd, at least until we know the cause. We do not say anything is impossible. We want to know why a thing is possible or impossible. We are attempting to define the properties of matter beyond the physical. We never will try to say what matter is."

BSRA 9. **LETTERS TO A SOLDIER:** A 30-page mimeo booklet compiled during the 2nd world war and addressed primarily to service men and others who have no information whatsoever, concerning the death experience and the varying conditions that may accompany it. Elementary data of spiritism and occultism presented for information, not from a religious or sectarian angle. The second part of the booklet explains, without dogmatism, the basic concepts of occult thinking, such as the various "planes" and "vehicles". A copy of this booklet, in the hands of the "right" person, might easily prove a gift of very great importance.

"There is a kind of taboo on the subject (of death) in ordinary life, and when you young men leave us on the road to war, we do not speak of it to you or among ourselves. Yet death, along with birth, is the common human experience, unavoidable for every living thing. And the great mass of humanity believes, and has always believed, that we go on living again after death, somewhere and in some way. If there is any knowledge at all to be had concerning this matter, it is only commonsense that everyone should possess it. Our fear of death should be lessened by it and our experiences on the "other side" made much easier. . ."

BSRA 12: PREVISIONAL ATOMIC RESEARCH: By Edward S. Schultz, BSRA. Mimeo., 20 pp. A remarkable scientific forecast of possible developments and applications of atomic energy. A number of these predictions have already been fulfilled, others are likely to take shape at any time. They range from nuclear perfumes and "nucleonics in the boudoir" to pile reactors, tagged currency, Nitrogen fixation, radioactive teeth and new fission reactions. A BLUNDER OF FIRST MAGNITUDE

According to the daily press of the week of July 24, 1952, orders have been issued by military authorities to pilots and other operators of armed aircraft to pursue and, under some circumstances, to attack with gunfire, as opportunity offers, the so-called Flying Discs or Flying Saucers. THIS IS, IN EFFECT, AN ORDER TO COMMIT SUICIDE AND TO INVITE RETALIATION IN A MOST EXTREME AND DISASTROUS FORM.

The Director and Associates of the organization offering this brochure have for six years been engaged in an intensive study of the phenomena of the Discs; nevertheless the first facts here presented are familiar and easily accessible to everyone.

It is abundantly evident that these craft are operated by highly intelligent beings, and that they far surpass any type of aircraft so far constructed by us.

They excel our aircraft in speed, maneuverability, and power, to such an extent as to make them immune from pursuit and attack, except by their own choice. We have at present no weapon with which to engage them effectively. An exhaustive study of their observed operations and control plainly indicates that they have our nation, and the planet itself, at their mercy.

NO ACT OF THEIRS HAS INDICATED ANY HOSTILE INTENT. NO FAINTEST EXCUSE CAN BE OFFERED FOR THE PROPOSED ATTACK ON THESE FRIENDLY VISITORS TO OUR SKIES.

Numerous incidents, however, during the last six years, strongly indicate that the operators of the Discs or Saucers have abundant and deadly means of retaliation. We cannot estimate the disposition and mentality of these beings, or put any limit to the destruction they may inflict upon us if we make unprovoked attack. All sources from which we have derived plausible information warn us with one voice:

DO NOT ATTACK THE "SAUCERS" - IN THE NAME OF GOD, DO NOT ATTACK THEM!

The repeated and desperate vehemence of this warning surpasses description. It is within the power of these visiting peoples to destroy cities and continents and even the planet itself. We have no guarantee, no reason to assume that they will not exert such powers. We have no right to suppose that they will suffer our attacks without retaliation, or that they will engage in prolonged and tentative hostilities only. It is far more likely and logical that they will subjugate our planet at a single blow.

"IN THE NAME OF GOD, DO NOT ATTACK THE SAUCERS!"

They come in friendship, with a science over-matching ours by a thousand years. They are engaged in scientific studies of geophysical changes and of our social and political conditions. Their present incursion (one out of many in the course of history) was occasioned by the release of atomic energies, which disturbed and alarmed the worlds of their habitation. This threat has now been contained by them, so that their chief concern is with certain startling changes occurring deep within our globe. But they impose no law upon us (though they could enslave us if they so desired), they exact no tribute and move harmlessly through our skies.

IF WE CAN AND WILL MAKE FRIENDLY CONTACT WITH THEM, THE GAIN TO OUR SCIENCE, PHILOSOPHY, AND COMMON WELFARE WILL BE LIMITED ONLY BY OUR OWN CAPACITY TO LEARN.

(The first practical and simple step would be to repeat, by batteries of colored lights, the light changes observed on the various globes, Discs, and other craft).

Make friends with these people. Do not attack them. Try to learn from them - for we are children in their hands.

We do not make this appeal from the standpoint of any cult or religion and make no financial gain. And we cannot expound here the scientific and metaphysical concepts underlying our statements. A volume would not suffice for that purpose, since such ideas are unfamiliar (and hence unwelcome) to the Western mind. But the Visitation (as we may call it) is no metaphysical abstraction, but one of the most pregnant events in human history.

No one can predict the conduct of these Visitants - but it is certain that they are very wise, and very powerful, and so far well disposed. Yet a single piece of incredible human folly, such as the Order to Attack referred to in our first paragraph, may crumble our cities, wreck our civilization and devastate our globe.

If we are indeed to be destroyed by fools in high places - then that perhaps is written into our destiny. But as a people, this quietism is not within our nature; we struggle and protest against the fools whom our own folly has raised up. And as to this present issue, this insane Order to Attack, we make appeal (hoping that it is not already too late) to ALL PERSONS IN AUTHORITY EVERYWHERE, AND ESPECIALLY IN THE ARMED SERVICES, to immediately forbid and overrule such orders.

IN THE NAME OF HUMANITY AND COMMON SENSE.

The danger is real, imminent, and of a magnitude which our present pages cannot describe.

DO NOT ATTACK THE "SAUCERS", IN THE NAME OF GOD, DO NOT ATTACK THEM!

A FEW FACTS CONCERNING THE DISCS OR "FLYING SAUCERS",
THE "FIREBALLS" AND OTHER RELATED AERIAL PHENOMENA.

Denials of the factual existence of the Discs or Saucers, though they still persist with certain "authorities" and "experts", are no longer worth serious attention. Such denials are rooted either in (a) an incredible ignorance, especially of the historical background (b) an equally incredible stupidity, or (c) considerations of supposed public policy, orders from superiors and the like. The end of this servile and moronic evasion is now at hand, and extraordinary events are in the making.

Nearly all of the disc-shaped flying objects come from the etheric double of Venus (not from the visible planet). They are operated either by people who are natives of the etheric worlds, or by incarnate humans who are now living on etheric (not astral) planes. They have visited our planet hundreds of times in the past. They appear, as a rule, at times of racial and planetary crisis, for purposes of scientific observation and study. Their chief present interest is in deep-lying changes in the geologic structure of the earth's crust. They come in good will and could be of immense service to us, if we were friendly and cooperative.

The concept of the ether(s) as a universal medium of enormous density should be acceptable to any physicist. Matter as we know it is a rarefaction of the ethers and the denser media pass through our matter like wind or water through a mesh with mile-wide interstices. There is an 'infinite' series of ethers of increasing density - atoms within atoms within atoms without end. These form worlds of living existence outside the spectra of sense perception (sight, hearing and touch).

There is an infinite variety of visiting 'sky craft' besides the "saucers", and some come from enormous distances measured in light years. Their method of 'crossing space' belongs to a super-physics which cannot be discussed here - but the basic fact seems to be, that these craft are made of a 'special kind of matter', in which the alignment of the atoms prevents the merging of their magnetic fields. This renders them weightless, and the energy-thrust is due to their rapport or resonance with the atoms of the ethers.

Our information states that many discs or saucers are being seen over Russian territory, and that the Russians are intensely interested in them from a scientific standpoint, and the possibility of constructing similar craft. Such an achievement would make Russia (or any other country) the master of our planet in a few weeks or days. We invite the attention of governmental authorities to the content of this paragraph.

The Etherian peoples are not all alike, but are of many races and cultures. The word Etherian is very inadequate, but the best one available in our language. The existence of these worlds and peoples has always been recognized in Oriental metaphysics; and our own world is rooted in the etheric plane and originated from it. The ether has the same type of reality as has the magnetic field around the poles of a magnet.

The so-called Fireballs in some instances are "wipers" designed to offset the radiations and fission products of atomic explosions; in other cases they are photographic devices which transmit an image while in flight, of both the inside and outside of any object.

The present terrestrial situation is briefly this: The island universes are entering on a phase of cosmic expansion, the earth is entering new space-conditions, the etheric stresses are changing, and hence the internal stresses of the globe are affected. Deep-lying strata are disintegrating and a period of violent seismic disturbances is at hand. These are of profound interest to our Etheric visitors. No mistake could be more serious than to attack the Discs or any other type of etheric craft now present in our skies.

The BSRA Hdqrs. will make an effort to reply to any serious and specific inquiries.

FOR INFORMATION OF THE PUBLIC - AND THE SAKE OF THE RECORD-
A SYNOPSIS OF IMPORTANT DATA.

1. More than five years ago, in the fall of 1946, Associates of the Borderland Sciences Research began an investigation of certain strange aerial phenomena known as the flying Discs or flying "saucers", and since that time these have greatly increased in number and complexity. The BSRA have printed many hundreds of pages dealing with these occurrences, and have issued several condensed reports similar to this present one. This does not imply that the original explanation, offered by us in 1946, has proven invalid; but only that much additional data has accumulated which requires comment. We realize that the data as a whole, and the explanation of them, are unintelligible except to a few highly informed people - and consequently appear repugnant or alarming. The difficulty is increased by the fact that no single and simple statement can be made covering the whole situation. But data offered in the following paragraphs are believed to be substantially correct. Obviously, we cannot here enter upon the scientific and metaphysical argument involved.

2. (a) The visiting space-craft are of many kinds, varying widely in appearance, points of origin, and purposes. They come from different parts of the solar system, and even from enormous distances beyond. (b) Most of the disc-shaped craft come from the etheric regions (etheric double) of Venus (c) There is reason to believe that some of the 'discs' are operated by ex-carnate humans who are now resident on the etheric Venus; but it is likely that some discs, and numerous other craft, are under the control of Etheric people (not ex-carnate humans). (d) It is probable that some of them do come from visible celestial bodies and from dark stars. (e) The first small discs, some of which were forced down by navigational difficulties, came from the Moon (which served as a base only). (f) "Mother ships" are being used for both Discs and other types of craft; these are of great size and hover above the upper limits of our atmosphere. The small craft seldom undertake the interplanetary voyages.

3. (a) The propulsion used involves utilization of earthian and interplanetary magnetic tides - i.e., the ethers. The craft are made of a type of matter in which the alignment of the atoms is such as to prevent the merging of their magnetic fields - which renders them weightless or almost so - and the energy of the drive is derived from a rapport or resonance with the atoms of the ethers (b) the "speed" of transit is so great that it amounts to a tele-transportation. In fact, tele-transportation is the most easily understood comparison. (c) The very fine and enormously dense matter of the ethers is responsive to thought-energy, and the craft are constructed by being thought-into-form. (d) On entering the magnetic field of the earth (or any other body) the vibration rate is "converted" and the object (disc) may then become visible to us. (Any kind of apparatus has to conform to the vibratory rates of the plane where it is supposed to operate).

4. The present visitation of Etherian (and other) people is NOT a new phenomenon, but has occurred many times and in various forms throughout history (A considerable list of such occurrences during the last century has recently appeared in a national magazine). The smallest historical knowledge would have prevented many ridiculous conjectures and 'explanations' by 'scientists' and 'experts'.

5. The motives for such visitations are various and complex, and include (a) scientific observation and study of earth life (b) a willingness to help earth people against impending crises (c) Self-protection.

This last factor (seldom present heretofore) arose with the release of atomic energy and fission products, and with the great danger and probability of a war in which atomic weapons would be used.

The release of atomic energies seriously disturbed the etheric worlds and their inhabitants, and in fact the entire solar system. These energies have the effect of disrupting the stress line of the ethers, and this in turn releases the internal stresses of the globe. "All earthquakes are ether quakes at first" is now acceptable to many physicists. The Etherians appeared in our skies in self-defense, and some form of intervention seemed inevitable.

The imminent threat from atomic fission is said to have now passed, since the danger has been 'contained' by the Etherians, largely through the use of the green fireballs which served as 'wipers' and prevented further damage to the ionosphere.

The repeated rupturing of this ionized belt (which regulates the weather of our planet) accounts for the vagaries of world weather since the first atobomb explosions. (The chemistry of this has been sketched by several of our BSR Associates).

(Other 'fire-balls' are photographic devices, capable of transmitting an image (of terrain, any object, inside or outside) while in flight. They do not need to return to any point of origin, but disintegrate. The record (image) can be enlarged and temporarily preserved by other (Etherian) apparatus.).

6. The motivation of the present incursion, then, is not so much self-protection (as at first), as it is to scientifically observe deep-lying geological changes, the disintegration of strata far below the surface of our globe, and the great seismic disturbances which are expected to result.

While these interior changes accompany and result from a disruption of etheric stresses, the latter is now arising from other causes of cosmic magnitude. The island Universes (solar systems) are entering on a phase of cosmic expansion and the earth is encountering new space-conditions. One manifestation of these may be the occurrence of "dark days" (complete darkness), of which several instances are on record. They are caused by enormous clouds of interplanetary 'dust', and are harmless though alarming.

7. It is true that landings have been made by Discs and by other craft from outer space, and that meetings have been held between these visitors and certain earth people. Satisfactory 'proof' of this is of course impossible - and except as a hint of future possibilities is for the moment unimportant.

8. Perhaps the greatest difficulty which the Western mind encounters, in trying to conceive of 'Etherian' worlds and peoples, is to understand that what we call dense matter is really a rarefaction of the ethers - and that matter can not only be too rarefied for us to touch, but it can also be too dense. There is a spectrum of tangibility, just as there is of sound and color (hearing and sight). When an object in our world moves through the ether, or the ether through it, the operation is like the passage of wind or water through a mesh with interstices a mile wide. Soi-disant physicists who are boggled over the absence of 'friction' are recommended to a few minutes of reflection, plus a reference to (say) Eddington's "Nature of the Physical

World" (pg 3,30,31,32 et pas.). (These passages are also quoted in the BSRA publication Round Robin, vol. viii, 2, while the matter is threshed out in extenso in the BSR booklet "The Ether Ship Mystery and its Solution", q.v.) The relatively huge size of the interspaces within the atom is known to school boys, and the "army of symbols" referred to by Eddington "to account for the properties of the interspaces" has not yet accounted for a well-known bogie named actio in distans. What we seem to have (crudely put) is an 'infinite' succession of nesting atoms, worlds within worlds, ethers within ethers, but with no true continuum anywhere. And this highly rational concept, be it noted, has been known for ages to the despised metaphysics of the East.

9. It is obvious that the concept of the etheric worlds and people cannot be introduced to the Western mind (a moronic child in metaphysical matters) on short notice or in a few paragraphs; and the BSR Associates have never entertained such a notion. We have, however, endeavored to reach a few individuals and small groups who might serve as nuclei in a time of world confusion. Many occultists, and particularly members of Theosophical groups, have been highly responsive.

10. The great present need (which will not be met) is to establish friendly relations with the Etherian visitors. A first step would be, to reproduce by means of banks of colored lights, the color changes of passing etheric craft. Such relationships might help us to avoid a planetary disaster, and advance our science and philosophy by centuries. But, to repeat, it will not be met. Instead, orders have been issued (according to the press) to pursue and shoot down one or more of the Discs - "as a means of demonstrating their harmlessness". It is likely that the whole history of humanity shows nothing as moronic, and as deadly in its consequences as this reported order.

11. The "repairs" to the ionosphere effected by the 'wiper' fireballs will have the effect of concentrating the atomic contamination onto our own planet - with probable cumulative effects we would be reluctant to describe. A kind of 'planetary law' seems to exist, according to which the people of any planet may do as they please so long as the results are confined to their own globe and do not injure other worlds and peoples. The isolation of our planet, if effected as described, comes under this interplanetary law.

12. Something ~~may~~ yet be accomplished, at least for individuals and small groups, by disseminating such basic information as has been hastily summed up in these pages. While a known event may awaken terror, an unknown menace is more terrible still. In some degree it is alleviated by knowledge - by understanding a little about what is happening in terms of natural forces and ~~the laws~~ of astro- and geophysical absics. Our effort should be to put aside fear for one's personal safety, and ~~to help~~ ^{to help} others in every possible way in a time of world-wide confusion. ~~to try~~

13. There is NO danger from the people of the Discs unless we attack them. If we do, their retaliation may be swift and deadly, and far beyond our power to resist.

14. As matters stand at this writing (August 1952) the most imminent danger seems to be from seismic disturbances (earthquakes and volcanic action, subsidence, violent storms, 'electrical storms'). This is a planetary phase, of cosmic origins, and cannot be limited or mitigated by human efforts. But ignorance and fear can multiply such disasters to truly terrible proportions. The need for individual quietude and self-control has never been greater.
