### **Analysis of Problem**

### A. Budget Request Summary

The California Department of Social Services (CDSS) requests (20.0) Administrative Law Judges (ALJs) and video hearing equipment to address the increase in both caseload and complexity of cases associated with program changes.

### B. Background/History

The CDSS' State Hearings Division (SHD) provides administrative fair hearings to recipients and applicants of California public assistance programs. The primary programs are CalWORKs, CalFresh, IHSS, Resource Family Approval & Foster Care, Adoptions Assistance, Medi-Cal, and Covered California Affordable Care Act (ACA).

Two court orders, King v. McMahon and Ball v. Swoap, impose financial penalties on CDSS for failing to adjudicate hearing decisions within the legally mandated time frame. Timely due process for clients is critical because of the safety net nature of these programs and the imposition of penalties. CDSS must address this workload in a timely manner, or risk monetary penalties for late decisions under the Ball/King court orders, which must be paid with state General Fund.

In Fiscal Year 2017-18, CDSS received 16 additional positions to respond to healthcare program changes. These changes include the Center for Medicare and Medicaid Services final rule on three-day business expedites and the expansion of Medi-Cal coverage. The positions helped mitigate an increase in the need for hearing decisions caused by declining resolution rates. With these positions, substantial progress has been achieved in the areas of ACA and Medi-Cal Scope of Benefits appeals by creating and maintaining specialized units of ALJs/staff to address these workloads. For example, the resolution rates for ACA have dramatically improved and the daily penalty rate for Medi-Cal has dropped from \$87.50 in 2018 to \$7.50 in March 2020 (see Attachments B - Resolution Rates & C - Penalty Information). The Department of Finance previously approved eight (8.0) ALJ positions for FY 2020-21 to address the IHSS portion of this workload.

### C. State Level Consideration

Failure to meet legally required timelines for the issuance of hearing decisions results in monetary penalties that impacts the state General Fund. The delay in due process will potentially deny some of California's most vulnerable populations access to lifesaving services, medications, or child placements. The resources requested will help meet California Health and Human Service Agency (CHHS) goals to create efficiencies and provide faster delivery of services.

### D. Justification

The current yearly case intake is approximately 80,000 cases and about 23,000 decisions are issued yearly. Recent changes in CalFresh, Medi-Cal, Covered California and other programs are expected to increase case intake over the next several years as outlined below. Case complexity has also increased across all program areas despite continuing efforts at remediation. Other changes include redistribution of the ALJs workforce statewide to cover the oldest cases first. However, the department is unable to keep up with the complexity and increase in cases which has resulted in backlogs across all program areas. The current number of unscheduled cases now stands at approximately 10,531 statewide. Case penalties continue to rise and are projected to reach \$4.1 million by the end of the fiscal year.

The requested 20.0 ALJ resources are needed to address backlogs, penalty payments, and the following changes that have affected current workload:

- Rehearing Growth The number of rehearing requests has significantly increased over the last two years with no additional resources available to assist. In 2019, the increase of rehearing requests led to a backlog of 435 requests. Due to the growth in this workload, CDSS redirected two general jurisdiction hearing ALJs to address the backlog and ensure compliance with the statutory requirement to conduct rehearing determinations within 35 days of the request. This improved the rehearing backlog numbers, but also increased the number of unscheduled cases in other program areas due to the redirection of the two ALJs.
- Increased CalFresh caseload CDSS estimates that 369,000 new SSI/SSP enrollees will be added to CalFresh under the statutory change providing SNAP benefits to SSI/SSP recipients. For these new CalFresh recipients, it is anticipated that there will be an additional 4,428 hearing requests. CDSS will require ALJ resources to address the new workload and to address unscheduled cases on an ongoing basis.
- •Covered California Expansion Covered California estimates a preliminary rate change of eight percent in 2020. The increase in premiums will impact an estimated 922,000 people and result in 229,000 people becoming newly insured. CDSS estimates these changes will lead to approximately 5,725 hearing requests requiring additional ALJ resources. Further, the traditional uptick in Covered CA cases will require additional hearings beyond the current ALJ capacity.
- •Medi-Cal Expansion for Undocumented Young Adults New funding expands Medi-Cal coverage effective January 1, 2020. The coverage will include eligible young adults aged 19 through 25, regardless of immigration status. This population includes approximately 137,703 undocumented young adults in the first year. Nearly 75 percent of these individuals are currently receiving limited-scope Medi-Cal benefits. CDSS estimates approximately 936 new hearing requests per year relating to Medi-Cal eligibility. Additionally, CDSS estimates that the larger impact of the expansion will be on Scope of Benefit appeals. CDSS anticipates approximately 2,250 additional Scope of Benefit hearing requests for a combined overall total of 3,186 new requests related to the Medi-Cal expansion.

Other Changes to Medi-Cal Affecting ALJ Workload:

• County Children's Health Initiative Program (CCHIP) move to Managed Care - Effective October 1, 2019, this transition brought approximately 8,000 children in three CCHIP counties into the Managed Care rolls. This transition resulted in new and increased workload of an estimated 183 hearing requests per year. In order to address these high vulnerability and complex hearings, additional ALJ II resources are required.

- •Restoration of Optional Benefits Effective January 1, 2021, restoration of optional benefits for adult Medi-Cal recipients will cause an increased workload. CDSS anticipates this will generate approximately ten percent more Scope of Benefit hearings per month or 190 hearings per year.
- Aged & Disabled-Elimination of Senior Penalty Increased workload from the elimination of the "senior penalty" for approximately 20,000 aged and disabled Medi-Cal beneficiaries statewide, resulted in approximately 500 additional eligibility related hearing requests per year for share of cost related issues.

### Video Hearing Equipment:

To provide better efficiency in the hearing process, CDSS requests to expand video hearing capabilities in all 58 counties, all CDSS' SHD regional offices, and to all ALJs. CDSS conducts hearings in different modalities throughout the state in all 58 counties, requiring ALJs to travel. Hearings are held via phone, in person, or, to a very limited extent, by video. Current regulations permit CDSS to set hearings by video, subject to the claimant's absolute right to request an in-person hearing. CDSS is unable to utilize the time and cost savings associated with video hearings because video equipment is often unavailable. It is not always feasible to send ALJs to all county locations for various reasons including travel distances, insufficient ALJ resources, and scheduling conflicts. Video hearings have shown to be successful in accomplishing the same result as an in-person hearing, while maximizing state resources. Video hearings provide many of the in-person hearing benefits, such as observing witness demeanor, and the benefit of face-to-face interaction between the ALJs and the parties. This equipment will allow CDSS ALJs to be more efficient and hold more hearings because they will not need to spend long hours traveling. This efficiency will reduce case backlog and penalties.

### E. Outcomes and Accountability

Approval of the requested 20.0 positions will enable the CDSS to reduce backlogs and penalties for the benefit of recipients, stakeholders, and the general public.

These resources will allow CDSS to be in compliance with the Ball/King court orders and mitigate penalties. CDSS caseload will continue to be tracked and reported in monthly statistical reports and monthly penalty reports.






