The New Steel Cruiser Atlanta.

The three new steel cruisers Atlanta, which have been built by the Navy Department, and which were launched in the last twenty years have gradually declined in number, until only one of today would be as far as ships are concerned, simply helpless before any fourth rate power with whom complications may arise. The six new American cruisers, whose flying clouds of the States, whose "runs" have never been equalled even by the most expensive of modern steamships, are known by tradition by the present name of the Atlanta, and it is to be wondered at, therefore, that so little notice was taken of the launch of the latest, the new steel cruiser for our navy, which took place at the arsenal of the State. This vessel is one of a series of steel ships to be built for cruising, and is supposed to embody the latest improvement in speed, lightness, and general seaworthiness. She is of the following dimensions: Length, between perpendiculars, 270 feet; length on water line, 276 feet; length over all, 282 feet; depth from garboard to the middle of the main-deck, 15 feet 6 inches; height of main-deck, 15 feet; free board at extremities of superstructure, 9 feet; height of main-deck, 15 feet; mean draught at load, water line, 16 feet 10 inches. Displacement of water line, 3,000 tons. Area of plain sail, 10,000 square feet, comprising 10,000 square feet of four 8-inch and 6-inch breech-loading rifles, indicated horse-power, 3,500; sea speed, 15 knots; capacity of coal-bunkers, 800 tons.

There will be eight complete transverse bulkheads extending up to the main-deck. Longitudinal bulkheads will extend on each side through the main-deck, and will form side coal-bunkers, which will afford coal armor eight feet in thickness above the water line and five feet below it. Her coal will enable her to steam 2,500 miles at full speed, and at the rate of ten knots an hour. Her water-tight compartments are seventy-three in number. An inner water-tight bulkhead, extending the length of the ship, will divide the water-tight compartments into two equal parts. Her screw is of steel, and has four adjustable blades, with a mean pitch of twenty feet.

Her armament is distributed as follows: Outside the forward port angle and the after-ward angle of the superstructure an 8-inch long rifle gun will be mounted on a barbette about 200 feet high, each of 2-inch thick plates. The forward gun has a train from the forty degree shaft to the beam on the port side, sweeping the whole deck forward to thirty degrees ahead of the beam on the starboard side; the after-gun will have the same range.

Within the superstructure will be six 6-inch breech-loading guns, three on each broadside, with a train of sixty degrees forward and aft; the beam guns, forward in the starboard angle on the superstructure may be directed either forward or aft, or a broadside port, giving a total sweep of twenty degrees across the bow to sixty degrees aft. The last gun is mounted on the stern on the port side. The design, as far as the gun is concerned, is a fine appearance, towering above the machine-shop of the shipyard, the iron superstructure above her gun-deck, the masts on the main-deck, and the round hatchway gun towers on either side being novel features to American eyes.

Shortly after 3 p.m. a hundred workmen with sledges began to move the Atlanta to the water. Scores of visitors thronged her deck, and the crowd was so dense that the launch was delayed.
