KENYA GOVERNMENT OCCUPATIONAL TESTS Nos. I AND II FOR TELEPHONE OPERATORS—1974

IT IS notified for general information that this year's Occupational Tests Nos. I and II for Telephone Operators, details of which are set out in Personnel Circular No. 11 dated 22nd July, 1967, will be conducted as follows:—

- (a) The Written English Language Examination will be held on Thursday, 27th June, 1974, at 9.30 a.m.
- (b) Oral English Tests (for blind operators only) will be conducted here in Nairobi on Friday, 19th July, 1974, at 9.30 a.m. The actual venue for the Oral Tests will be notified to the candidates through their Permanent Secretaries/Heads of Department as early as possible.
- (c) The Programme for Switchboard Practical Tests for both sighted and blind candidates will be drawn up soon after the closing date for entries, indicated in paragraph 3 below, and will be released later to all Ministries/Departments in another Circular Letter.

ELIGIBILITY TO ENTER

2. The tests will be open to civil servants only who must be Kenya citizens serving with the Government of Kenya, and in the case of:—

(i) Test No. II

Should be serving Telephone Operators Grade III, with at least two years' service in that grade (including service prior to 1st February, 1966, as Switchboard Attendants Grade III or Grade II).

(ii) Test No. I

Should be serving Telephone Operators Grade II with at least four (4) years' service in that grade (including service prior to 1st February, 1966, as Switchboard Attendants Grade I or Switchboard Attendants/Receptionists Grade II).

(iii) Those candidates who failed their Occupational Tests in 1973 should not resit the tests in 1974.

ENTRIES

3. Candidates should submit their entry forms (in Triplicate) through their Permanent Secretaries/Heads of Department on the form (specimen at the Appendix) which was set out in Appendix "A" to Personnel Circular No. 11 of 22nd July, 1967, and which should be reproduced by each Ministry/Department, as required. The completed entry forms should be sent to the Secretary, Public Service Commission of Kenya, Gill House, Government Road, P.O. Box 30095, Nairobi, so as to reach him not later than Wednesday, 15th May, 1974. Under no circumstances will late entries be accepted, and the Permanent Secretaries/Heads of Department must ensure that the entry forms are correctly filled in, certified correct in all respects and submitted to this office within the dead-line.

REGISTRATION FEES

4. Each entry form must be accompanied by the appropriate fee of K.Sh. 10 only, for registration. This Registration Fee of K.Sh. 10 per candidate will not be refundable under any circumstances, and should be remitted in either E.A. Money Orders, E.A. Postal Orders (payable to the Secretary, Public Service Commission of Kenya) or cash. Personal cheques will not be accepted. The entry forms not accompanied by the Registration Fees will automatically be rejected.

Syllabuses

5. The syllabuses for Occupational Tests Nos. I and II are set out in Appendix "B" to the Personnel Circular No. 11 of 1967.

EXAMINATION CENTRES

6. (i) Centres for the Written English Language Examination will be at the Provincial Headquarters in Mombasa, Nyeri, Embu, Nairobi, Nakuru, Kakamega, Kisumu and Garissa. Ministries/Departments presenting candidates should specify clearly on the entry forms the appropriate centres at which their candidates should sit their examination. The venue of the test at each Provincial Centre will be notified to the candidates in due course.

(ii) All candidates will do their Practical Tests in their own offices and on their own Switchboards. The appointed Practical Tests Examiner will travel to individual candidate's place of work, as in the past.

EXAMINATION STATIONERY

Examination stationery and test papers for the Written Examination will be provided to the Provincial Education Officers in charge of the Provincial Centres by the Public Service Commission of Kenya and candidates will provide their own pens, ink, pencils and rulers.

CERTIFICATES

8. The Public Service Commission of Kenya will not issue any certificates to those candidates who will be successful in the Occupational Tests. It will, however, publish the names of all such successful candidates in the Kenya Gazette soon after the results of the tests have been declared out. This is the procedure followed for all the Government examinations conducted by the Public Service Commission of Kenya.

THE INDUSTRIAL COURT

CAUSE No. 44 OF 1973

Issue in dispute.—Wrongful redundancy of Wilson Awidha (Foreman).

1. The Kenya Management Staff Association shall hereinafter be referred to as the Claimants and Uplands Bacon Factory (K) Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on 19th November, 1973, and 19th February, 1974, and relied on their written and verbal submissions. The following witnesses were called by the parties to give evidence in Court:—

Claimants

Wilson Awidha.

Respondents

Basil Walmsley.

Michael Kimani.

Award

3. On 24th September, 1973, the Court received the Notification of Dispute Form "A" dated 1st August, 1973, duly signed by the parties' representatives along with statutory certificates under sections 9 (9) (e) and (f) signed by the Labour Commissioner and the Minister for Labour.

Wilson Awidha started work with the Respondents on 13th January, 1963, as a packing clerk at a salary of Sh. 210 p.m. plus free housing and on 28th October, 1970, he was promoted to the position of supervisor at a salary scale of \pounds 600 by \pounds 40 to \pounds 1,160 p.a. During the intervening period he was promoted to other positions although a couple of warnings were given to him but he was also commended for his good work and once won a prize of Sh. 100 for a sales development suggestion. In July, 1969, when he was in sales department he narrowly escaped summary dismissal when a shortage of Sh. 829 was discovered in his sales figures. He pleaded for forgiveness and promised to make good the shortage. Because of this incident he was retransferred from sales to production department.

There were a few other incidents also in which he was adversely involved but the fact remains that he received as much recognition for his efforts as he was disciplined for his weaknesses.

On 11th September, 1972, he was suspended from duty pending further investigations on the allegation that he had wrongfully consigned goods to Dar es Salaam and Kampala. He was, however, reinstated after the goods had been returned from their respective wrong destinations unspoiled. The Respondents, however, suffered a total loss of Sh. 11,878/30 in freight charges. The Court has taken note of the fact that the Claimants state that Mr. Awidha was not responsible for this mixup and the subsequent loss.

On 13th March, 1973, Mr. Awidha received another letter of warning regarding an incident when it was alleged he interfered with an Inspector/Checker in his official duties and manhandled him. It was alleged that he was also very discourteous to the Production Manager who inquired into the incident.

On 23rd March, 1973, he was again suspended from duty because serious discrepancies and irregularities had come to light when a physical check of goods against packing slip No. 117022 dated 22nd March, 1973, was carried out. He was suspended pending the General Manager's return from Mombasa and was told to make himself readily available should he be required to answere any queries.

On 30th March, 1973, he received the following letter:-

"As a result of reorganization, which is very much overdue within the production department, it has been decided that the company will no longer require your services from 31st March, 1973. You are therefore requested to call on the Company Secretary who will pay you whatever is due to you in accordance with your terms and conditions of your service."

The Claimants took up the matter on his behalf and have challenged the validity of the Respondents' action in terminating the services of their member Mr. Awidha on the grounds of redundancy without the prior approval of the Industrial Court as required under the provisions of the Trade Disputes Act. They reported a dispute with the Respondents on this ground to the Minister for Labour.

During the hearing the Claimants submitted that the word "reorganization" which the Respondents had used in the letter of termination implied that there was redundancy. They submitted that the Respondents had earlier issued a circular stating that redundancy was contemplated and that Mr. Awidha was in fact declared redundant.

The Claimants strongly refuted allegations of incompetency and carelessness on the part of Mr. Awidha and said that the Respondents were determined to get rid of him at any cost.

They asked the Court to declare that the redundancy was unlawful and to order Mr. Awidha's reinstatement with full benefits.

The Respondents contended that they had been more than fair with Mr. Awidha and had given him more than enough opportunities to improve on both his personal conduct and on his work but he had turned out to be a total disappointment to those who had entrusted him with responsibility.

The Respondents strongly denied that Mr. Awidha had been declared redundant and emphasized that they had used the word "reorganization" in his letter of termination so as not to prejudice his chances of securing other employment. They pointed out that Mr. Awidha's job has not been abolished and is to be filled in the near future.

For the aforesaid reasons they asked the Court to uphold the justifiable dismissal of Mr. Awidha.

The Court notes that the Claimants' action is based on the argument that Mr. Awidha was declared redundant and since Industrial Court's permission was not sought the redundancy is unlawful.

The Court, however, is satisfied on the submissions and the evidence tendered during the hearing that Mr. Awidha was not declared redundant. The Claimants' argument, that because Mr. Awidha's services were terminated due to reorganization therefore this must be a case of redundancy, is not sound. If reorganization is accompanied by or results in the reduction of staff then it would be redundancy, but reorganization can also be carried out without reducing staff.

The Court finds that the Respondents were motivated in using the word reorganization in order not to spoil Mr. Awidha's chances of getting other employment.

As far as the reasons for the termination of Mr. Awidha are concerned, they are not very relevant in view of the line of action that the Claimants have pursued. Further the issue in dispute is clear in that it is wrongful redundancy of Mr. Wilson Awidha (Foreman).

The Court would like to record that it is satisfied on the material before it that the Respondents had sufficiently sound reasons for terminating the services of Mr. Awidha.

The Court, while confirming that Mr. Awidha is entitled to one month's notice and all other benefits due to him, rejects the Claimants' demands asking for his reinstatement.
