Art is a very big part of the Ibizan Hound world. From ancient Egyptian hieroglyphs to modern pop art, people have been using tools to create depictions of our breed for thousands of years. We are fortunate to have quite a few remarkable artists within our breed, and many other dog artists, particularly those with sight-hounds, have produced amazing pieces featuring beezers as seen through their eyes. I hope to be able to feature at least one per issue for the foreseeable future and beyond.

As this is the Third Eye issue before our National specialty, it makes sense to start with the artist who is making the trophies. Jessica Lyn Stover is a 26-year-old dog groomer who lives in the city of Oak Harbor, located on Whidbey Island, Washington. She currently has three Ibizans: Rosa, CH Distinction's Roses Are Red (Melqart's Baal x CH Bramblewood's Minnie MiMosa), Ice, CH Arbeca's Rossinyol (Arbeca's Ellington at Newport x CH Blaia de El Pollet), and the new puppy Bixby, CH Veloz Be Still My Heart (GCHB SunRumba's LoveStruck By Life x Arbeca's Jump for Joy). She also has two Manchester terriers, Mac and Wendy, that fit right in with the big dogs.





Jess began drawing and painting at a very young age. She sold her first commission at just 11 years old! She is completely self-taught, beginning with basic doodles and drawings and continuing to practice, practice, practice to get to the lifelike pieces she does today. She primarily works with acrylic paints but is equally adept with watercolors and graphite. She doesn't stick to the traditional papers and canvas, either; she often does paintings on slate stone, wood, bronze pendants, and a myriad of other surfaces. Almost all of her pieces are sold, donated, or gifted, with few staying in her possession.

Dogs are almost always the focus of her work, with an occasional rabbit or cat working its way in. Her first whippet was a big inspiration for her early sighthound pieces. When she began working with Ibizans as a Junior Handler she immediately fell in love and added the breed to her repertoire before acquiring Rosa.

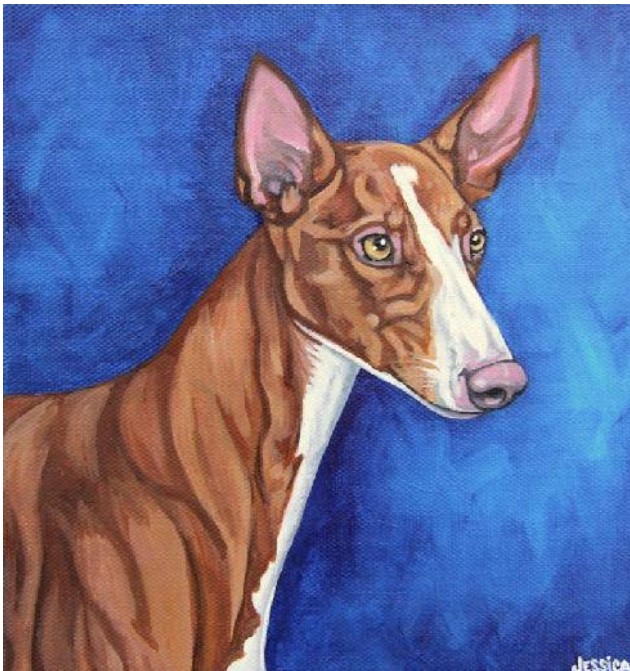
When recreating Ibizans she finds getting the correct color and pigment to be the most difficult part. "Using too much shadow can give the dog a darker appearance especially around the eyes, nose, lips and ears. Balancing flesh tones while still creating shadow and depth can be tricky sometimes."

Jess's work has evolved over time and she continues to experiment and learn new skills. She hopes to eventually start making sculptures, one of the most challenging forms of art. Most any type of art is a potential future project because as she puts it, "These dogs make great subjects, any medium can capture their beauty!"

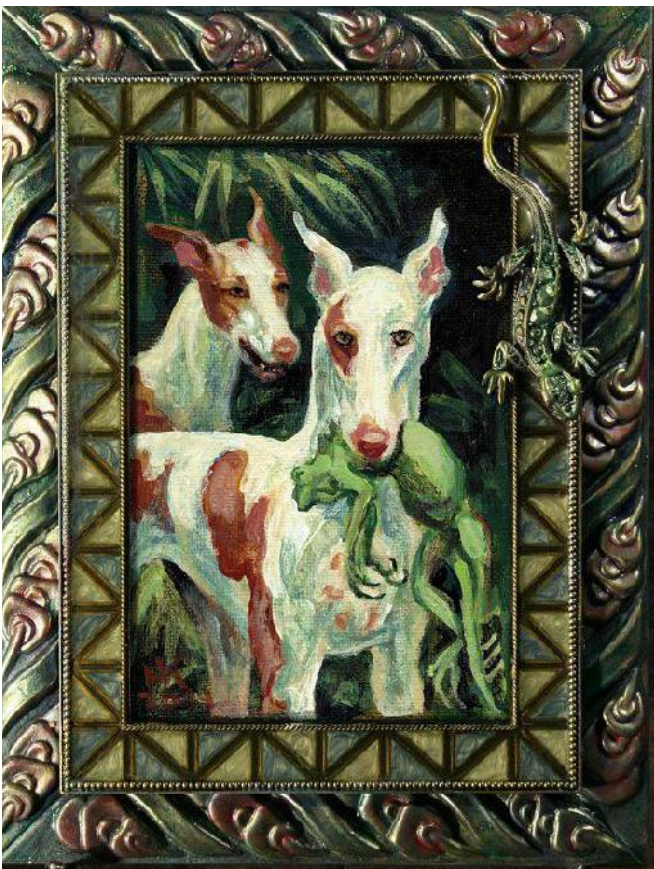

A HUNTING WE WILL GO...



Ibizan Hounds are bred to hunt! By instinct, form and function most are very prey driven. Sadly, in this day and age, there are few opportunities for our hounds to express their Raison d'être.

Some Hounds and Hunters live in areas where lure coursing events are held. This is a fun and exciting activity for all!

There are a few very lucky Hounds and Hunters who have access to large tracts of land where the coursing of live game [hares] is permitted. Hunting, chasing and capturing live game is mentally and physically rewarding. I am sure the participants in this activity are in tip-top condition in mind and body! Given that I live in an area far far far away from any tracts of land that allow lure coursing or hunting, my Ibizans have discovered a unique way to hunt live game.... Where I live, in the Florida Keys, there are no places for my Ibizans to hunt other than in my fenced in yard. The only rabbits here are an endangered species of marsh bunny and there are no squirrels.

We are blessed in that our dogs are able to fulfill a number of needs and desires and also rid our property of a serious pest.

Nonnative Green Iguanas are a popular pet and are often released when the owners tire of caring for their pet. Because south Florida has a similar climate to the iguanas COO and there is an abundance of food and no natural predators, this species has boomed. One of the reasons these reptiles are so destructive is that they eat the foods that our native butterflies, deer and birds depend on. Our Raine is a staunch environmentalist protecting native plants and animals from this exotic invasive species! Raine has stalked, captured and eliminated over 70 from our backyard. She has admirably performed the vital task of protecting our vegetable garden, our orchids and our health. She is known all over the world as The Dragon Slayer and has had a painting, a caricature, and a cartoon done in her honor.

ATTENTION MEMBERS: Deadline November 1, 2017

If you wish to host an IHCUS National Specialty, the IHCUS Board is officially asking you to submit an application by November 1st for the 2019 and/or 2020 Specialty years. All **completed** Specialty applications will then be provided to the membership for a vote. The applications and proposed locations will be published in the Winter 2018 IHCUS Newsletter, "The Third Eye" with a ballot for the membership to vote on their choice of applications.

The Application Form and Guidelines may be downloaded from the IHCUS Website: <http://ihcus.org/forms/> or hard copies may be requested from the IHCUS Secretary, Cathy Hjelm at secretary@ihcus.org.

The intent the Application Form and Guidelines is to provide sufficient detail that even inexperienced members can feel confident to apply for and put on a successful National Specialty. Those considering applying who have questions may contact Christy Shaw at president@ihcus.org.

Per our Bylaws, applications may be submitted by IHCUS affiliated clubs or a committee of individual members for any time or location. The IHCUS members voted that if no applications are received by the deadline, the location will automatically default to Purina Farms, MO. This does not mean that a member cannot apply to host a Specialty at Purina Farms or to volunteer to chair the Specialty if it defaults to Purina Farms. If you are considering Chairing a Purina Farms Specialty contact the IHCUS Secretary who can turn over contact information etc. that will assist you in putting your application together.

Remember, IHCUS is a small club with an even smaller number of active members, a portion of which attend our National Specialties. IHCUS is fortunate that many of you have already either chaired or played major roles in putting on a National and given to the club and breed in countless ways. Many members contribute in other ways but that does not solve the problem of those necessary to work and chair a National. You are needed to help maintain the successful level of events and entries of the past few specialties. Old timers know IHCUS has not always been able to offer ASFA and AKC lure coursing, health clinics, agility, rally, and obedience in addition to conformation. The choices available are determined **on completed applications** submitted by the deadline. Application selection is based on the votes received by IHCUS members.

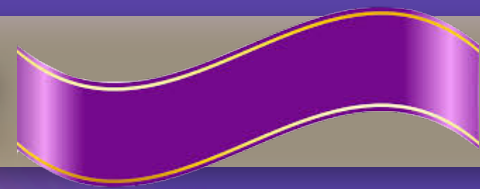
Chris Allen
