Arkansas Alcohol & Drug Abuse Coordinating Council (July 25, 2019, Minutes)

Main Commission Room -AR State Police Building (#1 State Police Plaza Drive, Little Rock, AR 72209)

I. Council Members Present

II. Call to Order

After roll call, Council Chair Kirk Lane recognized a quorum. The previous meeting minutes for June 2019 minutes were reviewed; Bob Parker motioned to approve the minutes, with a second by Paul Stevens; All approved.

III. Law Enforcement Committee Report

The Law Enforcement Committee did not report, said Chief Minor.

IV. Policy & Procedure Committee Report

The Policy and Procedure Committee did not meet, said Kirk Lane.

V. Prevention & Treatment Committee

The Prevention & Treatment Committee did not meet, said Phil Hall.

VI. DF&A Financial Report:

Hemphill reported on the monthly memorandum provided to the Council which includes state and federal balances for the Special State Asset Forfeiture Fund (SSAFF) and the State Drug Crime Enforcement and Prosecution Grant Fund (Drug Crime Assessment Fee Fund). As of June 30, 2019, the cumulative totals for the SSAFF & the Drug Crime Fee Assessment Fund (DCFAF) are as follows:

- SSAFF balance is \$71,321.26;
- DCFAF balance is \$1,475,813.42;
- DCF grant expenditures totaled \$4,019.74;
- DCF total deposits are \$108,942.72.

VII. DAABHS Prevention, Treatment & Recovery Report

Statewide Individual Treatment Services Outcome Report (May 2019)

For the Statewide Substance Abuse Treatment (self-reported) data for April 2019, Phil Hall reported there were 374 adult admissions, 7 adolescent admissions, 2 pregnant admissions, for a total of 381 admissions. The primary substance of use was (1) methamphetamine, (2) alcohol, and (3) marijuana/hashish. There were a total of 235 discharges.

DASEP Report (May) **self-reported* – Hall reported 1,109 individuals were screened for a total of 11,284 individuals screened during this fiscal year. Education was provided to 538 individuals for a total of 5,747 individuals educated during this fiscal year. \$97,025 in fees was collected for a fiscal year total of \$969,640.

Quarterly report on Opioid Maintenance Treatment – As of June 30, 2019, there were 1,068 enrolled in Opioid Maintenance Treatment; 137 were from out-of-state; 84 traveled 55 miles or more one-way for treatment; 600 were male, 468 were female, 42 were black, 990 were white, 26 were Hispanic, and 10 listed as other race. The top 3 primary substances of addiction: (1) 449 for Hydrocodone, (2) 434 for Methadone, and (3) 266 for Oxycodone. Quarterly totals: 181 admissions, 100 discharges, 8 pregnant, and 2 patient deaths (not methadone related).

Prevention – Prevention Coordinator Joycelyn Pettus said for the *Substance Abuse Block Grant* that the Continuing Application Proposals (CAPs) were sent to the Regional Prevention Providers (RPPs) on April 1. CHI St. Vincent will not be completing a CAP for next year as they do not wish to continue to contract. UALR MidSouth has developed an RFP for Region 8 that will be posted in July. The RPPs have served a population of 1,531,764 as they provided populations through these strategies (for June):

- Information Dissemination: 144,828
- Education: 2,286
- Community Based Process: 66,142
- Environmental: 1,318,412
- Alternatives: 3
- Problem Identification: 5
- Section 1926 Tobacco: 88

MidSouth updated the online Substance Abuse Prevention Training and the changes were uploaded in June. The following are the number of people who completed the training for June 2019:

- Prescription Drug Misuse and Abuse: 12
- Heroin, Cocaine, and Other Drugs: 11
- Marijuana and Other Drugs: 13
- Tobacco: 13
- Alcohol: 19
- Substance Use and the Military: 16

For the month of June, a total of 21 people completed the training. This represents a total of 2,605 (completion of any section) and represents approximately 883 different individuals since the trainings went live on July 25, 2017. (For further details, see the July AADACC packet)

For the *Partnership for Success Grant*, Pettus said in June that MidSouth developed the PFS Marketing Campaign – RAAD (Rise Above Alcohol & Drugs)

The *Prescription Drug Overdose Grant* and *State Targeted Response to Opioid Crisis* details are listed in the July AADACC packet provided by DAABHS PDO Project Director Helenia Valencino. For June 194 First Responders and 57 School Nurses received Naloxone training.

DAABHS Early Intervention & Prevention Director Tenesha Barnes said for Arkansas Prevention Needs Assessment (APNA) which goes out to 6, 8, 10 and 12 grade students in Arkansas Schools – Barnes said they attended a Community Anti-Drug Coalitions of America conference in Dallas, Texas and Arkansas was being praised for accomplishments, five states have reached out to ask about how Arkansas achieved that success and three states have reached out to have Arkansas representatives assist them with their PNA participation from school districts. Barnes said the APNA booklet is available online.

Kirk Lane added that 146 school districts are participating, 17 declined to participate and 14 school districts gave no response. He said a letter was sent from his office encouraging school districts to participate in the APNA survey to improve data. Lane said they are looking at the data in our grants as part of an evaluation process. He encouraged members to reach out to school district officials who are not participating to encourage them to participate. Lane said the RPPs will go to the schools and do the APNA work. He said a lot of agencies use this data to apply for grants, and it will affect where services and funding will be implemented, “so it is a very important factor.” and it also includes non-drug & alcohol questions, including vaping, bullying, etc.

Treatment – State Peer Recovery Coordinator Jimmy McGill said they have successfully implemented peer recovery in the Division of Youth Services. He said the Peer Recovery Specialist has implemented a curriculum address drugs, alcohol and gang related situations for at-risk-youth. He said AFMC has applied for a grant for Franklin and Dallas counties that will allow Peer Recovery Specialists to work in those areas.

- VIII. **Mothers Against Drunk Driving (June) report:** Yolanda Holmes said there were 21 classes, 676 number of attendees, with a total revenue of \$8,243. She said weather related issues (flooding) caused a decrease in attendees and revenue, but they have provided alternatives to those that were not able to attend.
- IX. **Old Business** – Hemphill said they are working with the 3rd Judicial District Drug Task Force to revamp the DTF and to utilize the BRYNE JAG funds. Lane said in the June AADACC meeting, it was the will of the council to monitor the 3rd DTF and take no action at this time.
- X. **New Business** – Kenya Buffington, DFA Program Manager, said the JAG 19 Strategic Plan Core Team Planning & Assessing team continues to work on the plan, and a work in progress was submitted on June 25 with the JAG application, and the core team continues to meet and fine tune the goals and objectives. She said the plan is to have a completed plan by October.

A presentation on Data Waived Practitioner Mapping was given by Kent Thompson from AFMC, Roshonda Bowden and Peggy Hill from UAMS. Hill said the MATRIARC (Medication Assisted Treatment Recovery Initiative for Arkansas Rural Communities) program is a partnership with the Psychiatric Research Institute and the Arkansas Department of Human Services designed to expand evidence-based treatment for opioid use disorders. An addiction psychiatrist is available free of charge via telephone to offer consultations to primary care physicians, general psychiatrists, advanced practice nurses, physician assistants and mental health professionals providing medication-assisted treatment to patients dealing with opioid use disorder (for more information: <https://psychiatry.uams.edu/clinical-care/cast-2/matriarc/>). Hill said the program had a slow start but has progressed with time on increasing participation. She said they use

Project ECHO, which provides weekly video conferences to community health centers needing assistance in opioid addiction treatment. Hill said they now have 15 physicians signed up to take the Data Waivered Medication Assisted training and have physicians and nurse practitioners now calling them with interest in the program. She said the map (shown by Thompson during the meeting) not only shows where the MAT facilities are, but where the areas of need are as well. Hill said they will be on the road for the next 8-weeks in assisting facilities in becoming MAT waivered and having Peer Recovery Specialists in their offices, as well as finding grant opportunities.

Jennifer Shuler, DAABHS Nurse Practitioner/Co-State Opioid Treatment Authority, added that she has 42 nurse practitioners ready and willing to offer MAT but need collaborative facilities. Lane added that when the program started there were 80 MAT DEA-Waivered and we are now at 252 in the state. He said there barriers including individuals having to drive more than 50 miles for treatment, there's stigma attached with MAT from some physicians, there's misunderstandings about the value, and there's not a lot money in it. "Those are some of things we are trying to get past and understanding the value ... because treatment and recovery does work," Lane said. "When we first started this we were in the bottom 10% in the nation for the ability to provide [MAT] treatment ... we still have a long way to go, but we are getting there."

XI. Director's Update

Lane said there were 270 lives saved by naloxone reversals to date. He said in working with the State Board of Education, the DARE program for elementary age students has been revamped nationally including new curriculum including vaping and opioids. Lane said he evaluated the curriculum and pointed out that the students have take-home materials to speak to their parents about, which he said is important because the largest opioid overdoses statistically are the adults – thus, opening lines of communication. He has asked them to consider opening the curriculum up for middle school through high school students. He said they are considering having it implemented through the Criminal Justice Institute to train School Resource Officers and other personnel, starting in 2020. Lane said APNA may be an evaluation factor for the DARE program, and therefore he is pushing for a mandated APNA, "because we don't have a uniformed prevention program in our schools." He said there is not a standardized model, but DARE has worked hard on a "really nice model." Lane said CJI has agreed to pick up some of the funding based on funds received from the governor's office, for the DARE program. He said if everything goes well, it could be implemented into schools by fall of 2020. He said they have resubmitted a grant application with Blue & You to get 5 more [TruNarc™ Handheld Narcotics Analyzer](#) for Drug Tasks Forces to use on Arkansas interstates.

XII. Adjournment: The meeting was adjourned upon motion from Chief Hayes Minor.

D. Online Substance Abuse Prevention Training

II. Partnership for Success Grant

- The funding for this youth prevention grant was received by the state of Arkansas on September 1, 2018. The contract was received by UA Little Rock and was signed by UA Little Rock on January 16, 2019. UA Little Rock received its invoice to begin billing from the DAABHS on March 1, 2019.
- The Partnership for Success Prevention Specialist, Mallory Visser, began working at MidSOUTH on May 16, 2019.
- A Request for Proposal (RFP) was created for the thirteen (13) Regional Lead Agencies that will provide the Partnership for Success activities in each of the thirteen (13) regions in Arkansas.
