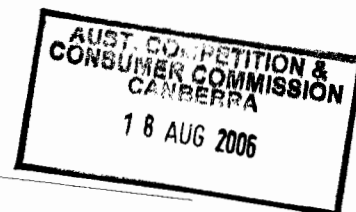

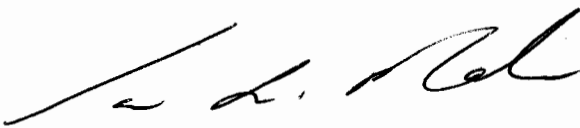

1. EXECUTIVE SUMMARY

ActewAGL and TransACT Capital Communications Pty Limited (TransACT) intend entering into an agreement under which the parties will co-operate to contribute one or more of the services they supply to residential customers ("Customers") throughout NSW. Customers may select various combinations of available services and will receive a rebate on the pricing applicable to the particular services.

ActewAGL is seeking statutory immunity under section 93 of the *Trade Practices Act 1974* for the proposed conduct. ActewAGL is aware that TransACT has also lodged a notification with the Commission to this effect.

2. CORPORATIONS INVOLVED

2.1 ActewAGL

ActewAGL Retail (ABN 46 221 314 841) is a partnership between ACTEW Retail Limited and AGL ACT Retail Investments Limited, subsidiaries of ACTEW Corporation Limited (ABN 86 069 381 960) (ACTEW) and the Australian Gas Light Company (ABN 052 167 405) (AGL) respectively.

ACTEW is a Territory Owned Corporation of the ACT Government. AGL is an energy company supplying energy products and services including natural gas, electricity and liquid petroleum gas to customers in Australia and overseas through various subsidiaries.

ActewAGL provides:

- electricity to customers in the ACT, and contestable customers outside the ACT;
- natural gas to ACT, Queanbeyan and Nowra customers;
- water and sewerage billing services to ACT customers on behalf of ACTEW Corporation Ltd (network asset owner); and
- dial-up and broadband internet service in partnership with TransACT Communications Pty Limited.

ActewAGL is authorised to supply natural gas to ACT and NSW customers, and electricity to customers in the ACT and NSW.

2.2 TransACT Capital Communications Pty Ltd

TransACT Communications Pty Limited is jointly owned by ACTEW Corporation Limited, TVG Transact Holdings Limited, SCA, AGL TransACT Pty Limited, Telent plc (formerly Marconi Corporation plc), Australian Capital Ventures Limited, Commonwealth Bank of Australia, MTAA Superannuation Fund (TransACT) Utilities Pty Ltd and Westscheme Pty Ltd.

TransACT Capital Communications Pty Limited owns and operates a broadband communications network in the Australian Capital Territory, which is capable of delivering voice, data and video (including subscription television).

In addition to the above, TransACT Capital Communications Pty Limited and ActewAGL Retail operate, in partnership, an ISP service trading as Grapevine (ABN 49 135 731 130).

2.3 Relationship of the Parties

ACTEW Corporation Limited has a 24.86% shareholding in TransACT Communications Pty Limited.

AGL TransACT Pty Limited has a 16.05% shareholding in TransACT Communications Pty Limited. AGL TransACT Pty Limited is wholly owned by The Australian Gas Light Company.

ActewAGL is a partnership between ACTEW Corporation Limited and the Australian Gas Light Company.

3. DESCRIPTION OF GOODS AND SERVICES IN RELATION TO WHICH THIS NOTICE RELATES

3.1 Description of the Services

The services to be supplied by each of ActewAGL and TransACT to Customers, and to which this notice relates, are as follows:

- ActewAGL services
 - Electricity
 - Gas
 - ISP services in partnership with TransACT
- TransACT services
 - Fixed line Telephony services
 - Mobile telephone service
 - ISP services in partnership with ActewAGL

4. PROPOSED CONDUCT

4.1 Summary of Proposed Conduct

ActewAGL and TransACT would invite Customers in NSW to acquire services from each of the parties. Depending upon the specific services acquired, the Customer would be eligible for a rebate on the price of those services.

Selection of the services is at the option of the Customer.

The rebate applicable to the various combinations of selected services is specified in the table below. Each of ActewAGL and TransACT will continue to independently determine the prices at which they sell their respective products and services.

Only selected TransACT mobile service plans will be eligible for the bundle. No rebate is applicable to the mobile service plan component of the bundle. However inclusion of an eligible TransACT mobile service will allow Customers, who would not have otherwise qualified, to be reimbursed for the cost of a TransMOBILE SIM connection. The offer is

limited to one SIM connection per bundle account. In relation to the SIM connection, the customer will be initially charged \$15.95. However, when all bundle products become active, the \$15.95 will be credited to the customers TransACT account. In effect, the customer will, when all products are active, receive a SIM connection at not cost to the customer.

Existing bundle customers (contracted under previous bundle contract arrangements) will be able to upgrade to the new bundles outlined in this application. Existing customers will not be eligible for rebates on services that they have already obtained when they first sign up to the bundle.

In order to obtain the applicable rebate, the Customer must enter into a 24 month service agreement with each party from whom one or more of the services are obtained (noting that electricity is a required service in each bundle). The Customer may enter into a service agreement with ActewAGL (to acquire the ActewAGL services), TransACT (to acquire the TransACT services) and Grapevine (to access ISP services). Existing payment options would apply.

The price of each of the services will be readily apparent to the Customer. The Customer would receive a bill from each of ActewAGL and TransACT in relation to the selected services. In relation to Grapevine, the Customer has the option of direct debit or on-line payment.

Customers signing up to a new bundle or upgrading their bundle to include TransMOBILE services may also be offered a free Nokia 1110i mobile phone after they activate their TransMOBILE SIM at point of sale. Further information on this offer is outlined at para 4.8 below.

The services would be jointly marketed by both ActewAGL and TransACT.

From time to time ActewAGL and TransACT may advertise special prices, packages, discounts or products in relation to a bundle. The terms and conditions for each promotion will be outlined at the time of the offer.

4.2 Rebate Scheme to be applied

The rebate to be applied to the available services is set out below:

For ActewAGL services, the applicable rebate will appear as a credit on a Customer's electricity account. Customers will not receive a rebate on their ActewAGL natural gas account. For TransACT services, the applicable rebate will appear as a credit on the Customer's telephony invoice. Rebates for ISP services will be credited to a Customer's ISP account.

In addition to the above, Customers will be eligible for a waiver of the Grapevine ISP connection fee, \$20 if that service is included in a bundle contract as a new service.

4.3 Compulsory Requirement of TransACT Service

In order to qualify for the applicable rebate on TransACT telephony services, a Customer is required to enter into a 24 month contract with TransACT.

4.4 Compulsory Requirement of ActewAGL Service

In order to qualify for the applicable rebate on ActewAGL services, a Customer is required to enter into a 24 month contract with ActewAGL.

4.5 Compulsory Requirement of Grapevine Service

In order to qualify for the applicable rebate on Grapevine services, a Customer is required to enter into a 24 month contract with Grapevine ISP.

4.6 Fixed Term Supply Agreement

The supply of services to a Customer is subject to a 24 month term. This lowers the running costs of providing available services by reducing overheads associated with Customer management. In order to meet associated administrative costs, an early contract termination fee will be payable by a Customer who terminates a service contract during the term. However this would be waived where it is no longer possible for TransACT, ActewAGL or Grapevine to provide the service(s) (eg where a Customer moves to an area that cannot be supplied by TransACT or ActewAGL).

4.7 Provision of Information to Customers

The bundle offer available to TransACT and ActewAGL Customers will be communicated through TransACT and ActewAGL call centres, press campaigns, the parties' respective websites and other means. TransACT and ActewAGL will ensure its Customers are aware of:

- the offer if the Customer elects to bundle services from TransACT, ActewAGL and Grapevine; and
- any terms and conditions applicable to the offer.

Customers will therefore be in full possession of all material relevant to a purchase decision prior to purchasing any services.

4.8 Free mobile phone offer

A further incentive is provided for Customers from Ulladulla, Moruya and Batemans Bay who sign up to a new bundle or upgrade an existing bundle at the outlets in those towns to include a TransMOBILE service and activate the TransMOBILE SIM at the point of sale. From 1 September 2006 until 31 December 2006 or while stocks last, these Customers will receive one free Nokia 1110i mobile phone. ActewAGL and TransACT will be purchasing the phones from Nokia.

This offer is to promote the opening of the ActewAGL and TransACT outlets in Ulladulla and Moruya.

This promotion will be advertised in ActewAGL's Essentials magazine. Terms and conditions for this promotion will be contained in the magazine.

5. PUBLIC BENEFITS

The impact of the proposed conduct is not such that, under the test laid down in section 93(3A)(b) of the *Trade Practices Act 1974*, the likely benefit to the public will be outweighed by the likely detriment to the public.

The proposed conduct would result in the following major public benefits:

- rebates applied to essential services;
- encouragement of significant investment in advanced local broadband communications infrastructure; and
- facilitation of competition within the telecommunications and energy industry.

5.1 Rewards applied to Essential Services

Persons who elect to purchase the available services will benefit from the application of rewards, as specified at paragraph 4.2. The specific rebate to be applied to the available services depends upon the combination of services selected by the Customer.

The proposed conduct will benefit Customers of electricity, gas, ISP and telephony services by providing them with a rebate on the services.

The electricity, gas, ISP, telephony and other telecommunications services will continue to be available to customers separately from ActewAGL, TransACT and Grapevine, and through other service providers.

5.2 Costs savings to customers

The bundling of an electricity supply contract with the services of TransACT and/or Grapevine should create a degree of stability in ActewAGL's electricity customer supply base allowing ActewAGL greater scope to secure more competitive electricity pricing.

5.3 Increased competition in the markets in which the ActewAGL services are supplied

ActewAGL believes the proposed conduct may provide Customers with an opportunity of acquiring services from ActewAGL at a lower price than the price currently charged by other competitors. This should, in-turn, stimulate competition in the supply of energy in NSW.

5.4 Competition within the Telecommunications Industry

The proposed conduct, through Grapevine, of the ActewAGL and TransACT partnership will promote the long term interests of telecommunications users by increasing competition in the telecommunications industry and promoting investment in advanced broadband communications infrastructure.

The proposed conduct will also encourage competition in the various markets in which other components of the services are supplied. For example, while qualifying for the rebate set out in paragraph 4.2, Customers may continue to have other services supplied by other energy providers or telecommunications companies.

The proposed conduct therefore does not reduce the choice available to Customers as it allows them to construct packages of telecommunications services and energy services from a range of providers.

6. PUBLIC DETRIMENT

It is ActewAGL's view that there will be no detriment to the public arising from the proposed conduct. The markets affected by the proposed conduct are those of electricity, gas, telecommunications and internet services.

6.1 No lessening of competition in energy supply

The electricity and natural gas markets in NSW are fully contestable with numerous suppliers of both gas and electricity.

ActewAGL believes there will be no lessening of competition given the number of energy suppliers in and around NSW, the large customer base of many of those suppliers, and that

full retail contestability has already occurred in NSW with retailers being seasoned operators within a contestable environment.

In ActewAGL's view, it is open to other energy retailers to offer a similar bundling of services with other telecommunication and/or internet service providers within the energy market of NSW.

6.2 No Lessening of Competition in the Internet Services Market

The Grapevine partnership between ActewAGL and TransACT (launched 19 April 2005) only has a small share of the internet market.

Grapevine competes with numerous local ACT (iiNet, Netspeed, Apex, Cyber One, Broadband Unlimited, Interact Broadband) and national internet service providers (Telstra, Optus).

The bundled services will not be detrimental to competition given the large number of other internet service providers, and the highly competitive nature of this market.

6.3 ActewAGL is dedicated to customer protection

ActewAGL is committed to ensuring that all customers and potential customers are provided with ample information relevant to the decision to purchase electricity and natural gas.

ActewAGL strives to ensure that its managers, representatives and approved dealers are aware of their responsibilities under the *Trade Practices Act 1974* and their obligations to protect both the competitive process and the interests of consumers.

ActewAGL holds trade practices training sessions for its staff at which issues of consumer protection are discussed. ActewAGL also provides a trade practices compliance guide to employees emphasising these issues.

6.4 Conduct Voluntary

It should be noted that the proposed conduct would be voluntary on the part of the Customer. The services will be available separately from TransACT, ActewAGL and Grapevine.

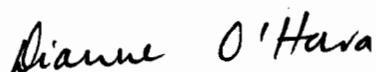

The Customer may enter into a service agreement with ActewAGL (to acquire the ActewAGL services), TransACT (to acquire the TransACT services) and Grapevine (to access ISP services). Existing payment options would apply.

The price of each of the services will be readily apparent to the Customer. The Customer would receive a bill from each of TransACT and ActewAGL in relation to the selected services. In relation to Grapevine, the Customer has the option of direct debit or on-line payment.

Customers signing up to a new bundle or upgrading their bundle to include TransMOBILE services may also be offered a free Nokia 1110i mobile phone after they activate their TransMOBILE SIM at point of sale. Further information on this offer is outlined at para 4.8 below.

The services would be jointly marketed by both TransACT and ActewAGL.

From time to time ActewAGL and TransACT may advertise special prices, packages, discounts or products in relation to a bundle. The terms and conditions for each promotion will be outlined at the time of the offer.

4.2 Rebate Scheme to be applied

The level of the rebate to be applied to the available services is set out below:

E = Electricity, G = Gas, I = Internet (Grapevine), T = Phone (TransTALK), M = Mobile (TransMOBILE)

For TransACT services, the applicable rebate will appear as a credit on the Customer's telephony invoice. For ActewAGL services, the applicable rebate will appear as a credit on a Customer's electricity account. Customers will not receive a rebate on their ActewAGL natural gas account. Rebates for ISP services will be credited to a Customer's ISP account.

In addition to the above, Customers will be eligible for a waiver of the Grapevine ISP connection fee, \$20 if that service is included in a bundle contract as a new service.

4.3 Compulsory Requirement of TransACT Service

In order to qualify for the applicable rebate on TransACT telephony services, a Customer is required to enter into a 24 month contract with TransACT.

4.4 Compulsory Requirement of ActewAGL Service

In order to qualify for the applicable rebate on ActewAGL services, a Customer is required to enter into a 24 month contract with ActewAGL.

4.5 Compulsory Requirement of Grapevine Service

In order to qualify for the applicable rebate on Grapevine services, a Customer is required to enter into a 24 month contract with Grapevine ISP.

4.6 Fixed Term Supply Agreement

The supply of services to a Customer is subject to a 24 month term. This lowers the running costs of providing available services by reducing overheads associated with Customer management. In order to meet associated administrative costs, an early contract termination fee will be payable by a Customer who terminates a service contract during the term. However this would be waived where it is no longer possible for TransACT, ActewAGL or Grapevine to provide the service(s) (eg where a Customer moves to an area that cannot be supplied by TransACT or ActewAGL)..

4.7 Provision of Information to Customers

The bundle offer available to TransACT and ActewAGL Customers will be communicated through TransACT and ActewAGL call centres, press campaigns, the parties' respective websites and other means. TransACT and ActewAGL will ensure its Customers are aware of:

- the offer if the Customer elects to bundle services from TransACT, ActewAGL and Grapevine; and
- any terms and conditions applicable to the offer.

Customers will therefore be in full possession of all material relevant to a purchase decision prior to purchasing any services.

4.8 Free mobile phone offer

A further incentive is provided for Customers from Ulladulla, Moruya and Batemans Bay who sign up to a new bundle or upgrade an existing bundle at the outlets in those towns to include a TransMOBILE service and activate the TransMOBILE SIM at the point of sale. From 1 September 2006 until 31 December 2006 or while stocks last, these Customers will receive one free Nokia 1110i mobile phone. ActewAGL and TransACT will be purchasing the phones from Nokia.

This offer is to promote the opening of the ActewAGL and TransACT outlets in Ulladulla and Moruya.

This promotion will be advertised in ActewAGL's Essentials magazine. Terms and conditions for this promotion will be contained in the magazine.

5. PUBLIC BENEFITS

The impact of the proposed conduct is not such that, under the test laid down in section 93(3A)(b) of the *Trade Practices Act 1974*, the likely benefit to the public will be outweighed by the likely detriment to the public.

The proposed conduct would result in the following major public benefits:

- rebates applied to essential services;
- encouragement of significant investment in advanced local broadband communications infrastructure; and
- facilitation of competition within the telecommunications and energy industry.

5.1 Rewards applied to Essential Services

Persons who elect to purchase the available services will benefit from the application of rewards, as specified at paragraph 4.2. The specific rebate to be applied to the available services depends upon the combination of services selected by the Customer.

The proposed conduct will benefit customers of electricity, gas, ISP and telephony services by providing them with a rebate on the services.

The electricity, gas, ISP, telephony and other telecommunications services will continue to be available to customers separately from both TransACT, ActewAGL and Grapevine and through other service providers.

5.2 Investment in Advanced, Local Communications Infrastructure

TransACT is currently deploying an advanced, fibre to the curb access network which is capable of providing a comprehensive range of narrowband and broadband telecommunications services.

The major services currently offered by TransACT to its customers throughout the ACT include:

- telephony services including basic access, local calls, long distance, fixed to mobiles calls, mobile calls and international calls;
- data services including dark fibre, leased lines, virtual private networks and high speed internet access;
- video services to support the broadcast of free to air television, subscription television and video on demand; and
- broadband and dial-up ISP services in partnership with ActewAGL.

TransACT is now seeking to further extend the reach of specified services to Customers within the regions surrounding the ACT.

TransACT is one of a small number of telecommunications enterprises that is making significant investment in the construction and deployment of advanced telecommunications infrastructure. TransACT customers within the ACT and the surrounding regions of NSW will continue to extract benefit from the provision of leading edge telecommunications facilities and services.

5.3 Competition within the Telecommunications Industry

Consistent with the stated policy objectives of the Federal Government, the proposed conduct will promote the long term interests of telecommunications users by increasing competition in the telecommunications industry and promoting investment in advanced broadband communications infrastructure.

The proposed conduct will also encourage competition in the various markets in which other components of the services are supplied. Depending upon the combination of services selected by the Customer, Customers could qualify for rebates and continue to have other services supplied by other energy providers or telecommunications companies.

The proposed conduct therefore does not reduce the choice available to Customers as it allows them to construct packages of telecommunications services and energy services from a range of providers.

6. PUBLIC DETRIMENT

It is TransACT's view that there will be no detriment to the public arising from the proposed conduct. The markets affected by the proposed conduct are those of telecommunications, internet services, electricity and gas.

6.1 No Lessening of Competition in the Telecommunications Market

TransACT competes with many other telecommunications providers operating in the ACT and surrounding regions of NSW. Similar services are offered by a range of other companies including but not limited to Telstra (telephony; dial up and broadband internet services; subscription TV), Optus and AAPT.

These companies currently offer bundled services which enable their customers who select a number of services to qualify for rebates.

The proposed conduct will not be detrimental to competition given the size and number of telecommunication operators, and the highly competitive nature of the telecommunications market to which the bundled services relate.

6.2 No Lessening of Competition in the Internet Services Market

The Grapevine partnership between TransACT and ActewAGL (launched 19 April 2005) only has a small share of the internet market. Grapevine competes with numerous local ACT (iiNet, Netspeed, Apex, Cyber One, Broadband Unlimited, Interact Broadband) and national internet service providers (Telstra, Optus).

The bundled services will not be detrimental to competition given the large number of other internet service providers, and the highly competitive nature of this market.

6.3 Conduct Voluntary

It should be noted that the proposed conduct would be voluntary on the part of the Customer. The services will be available separately from TransACT, ActewAGL and Grapevine.
