Therefore, we earnestly request the following:

Swift Legal Action: We implore you to initiate a thorough and impartial investigation into this incident. Identify and bring to justice every police officer involved in this assault. The gravity of the situation demands nothing less than a rigorous and unbiased inquiry.

Ultimatum for Action: We kindly request that you issue an ultimatum to expedite this process. If, by Monday, September 11, 2023, no significant legal action is taken against the responsible police personnel, we, the members of All Jammu and Kashmir Patwar Association, will have no choice but to call for an indefinite strike in all the districts adjoining Ramban District that is Doda Kishtwar and Udhampur. This strike will encompass both online and offline work, causing significant disruption until justice is served.

We earnestly hope that it doesn't come to the point of a strike, and that justice is served promptly.

We eagerly await your prompt response and action in this matter. We trust in your commitment to upholding justice and the rule of law in our region.
