

Dr. Caldwell was active in promoting the interests of Adel. He had probably done more in personal work, influence and the contribution of money to build up this place than any other citizen. He had been repeatedly elected to the office of mayor, was the president of the railroad built from Waukee here and continued its president until after its extension to Jefferson. He had been for many years the president of the Adel State Bank, had accumulated a comfortable fortune and owned much property here. 'In his death Adel has lost one of her most progressive and influential citizens. Some four years ago Dr. Caldwell was taken with a severe attack of heart trouble from which it was feared he would not recover, and while he did to a considerable extent recover his health, he was obliged gradually to relinquish his extensive practice and retire from active life, spending a large part of the past two or three years in California. He returned to Adel a few weeks ago feeling and looking much better. He was settling up some business matters and was planning to build a home at Denver for his future enjoyment. On Friday he was on our streets and no one imagined it was the last time his familiar face and form would be seen among us. The editor of this paper became acquainted with Dr. Caldwell in 1865, shortly after we had each returned from the war of the rebellion, and from that time to this we have numbered him among our most warm and constant personal friends, a man who has often showed his friendship in substantial We therefore personally pay a tribute of praise to his loyalty as a friend as ways. well as his excellence as a man. He leaves surviving him his wife, two sisters, Mrs. Irwin Maulsby of Des Moines and Mrs. Martha Allumbaugh of Napa City, Cal., his brother, Dr. J. J. Caldwell of Fort Bragg; Cal., and two half-brothers, C. C. Caldwell, of Grand Island, Neb., and A. B. Caldwell, who resides in Kansas. 

ADEL.

ALDWELL, TIMOTHY J., / M. D., physician and surgeon, was born in Vermillion county, Indiana, July 21, 1837; his father was William Caldwell; his grandfather was a prominent Baptist minister; he participated in some of the skirmishes with the Indians in Ohio, and built what is known in history as the Caldwell Blockhouse, located in Preble county. The subject of this sketch attended school and completed his literary education at the Newport Seminary, in his native county; he came with his parents to Iowa and located in Dallas county, in September, 1853; after working on the farm, helping his father for three years, he commenced reading medicine, and attended lectures in the medical department of the State University at Keokuk, now called the College of Physicians and Surgeons, and graduated from this institution in February, 1861; he located in Adel and practiced his profession there until 1864, when he was commissioned Assistant Surgeon of the 23d Regiment Iowa Infantry, and served in that position until the close of the war, returning to Adel in 1865; after practicing a few months he spent the following winter at Jefferson Medical College, in Philadelphia, Pennsylvania; since then has reaped the benefit of a thorough review of medical and surgical science; he spent the winter of 1877-8 in the city of New York, reviewing his profession; he went through the whole course at Belleview Medical College and University: he obtained all his medical education by zealous and untiring efforts at his own expense, and now stands at the head of his profession; he married Miss Melissa V. Maulsby, of Dallas county, Sep. 30, 1869; she is a native of Indiana.

CALLVERT, JUDGE S. A., was born in Albany, Whiteside county, Illinois, February 12, 1843. When twelve years of age he moved with his parents to Lucas county, Iowa, where they remained but a short time, then removed to Ringgold county, and there spent three years of his early life, attending preparatory school; in 1858 he again removed with his parents to Washington county, Iowa, and entered Washington College, where he received his classical education; during the winter of 1864-5, he attended the University at Ann Arbor, Michigan, and soon afterward entered the office of Judge Miller, of Iowa City, under whose able instruction he pursued the study of law until he was admitted to the bar before Judge Conklin, October 18, 1865; he then went to Marble Hill, Missouri, and practiced his profession until 1870, when he returned to Iowa and located in Nevada, Story county, where he continued his practice successfully for more than a year; but not yet feeling fully satisfied as to his place of permanent settlement, and more encouraging prospects opening elsewhere, one more move brought him to Adel, Dallas county, in September, 1871, where the paved pathway to profit and promotion soon began to appear; he pursued his calling here diligently for more than six years, gaining a good practice and growing in favor with the people, until in March, 1878, he was honored with the appointment of Judge of the Second Circuit of the Fifth Judicial District, and in October, 1878, he was elected to the same position by the people, which he now fills so acceptably, with credit to himself and honor to his constituents. On the 22d of June, 1868, he married Miss Rachel B.

and who married Susan A. Kellar, a native of Pennsylvania, but she died April 26, 1907; Grover C., who follows the barber's trade; and Benjamin H., who assists in the improvement of the home farm.

Mr. Merical has served as road supervisor for two terms and as school director for several years. He has never sought or desired office, however, preferring to leave that to others, while he has given his attention to his business affairs with the result that his labors are proving very profitable. He belongs to the Odd Fellows society at Dallas Center, and both he and his wife are members of the Christian church and are much esteemed in the community, receiving the warm regard of many friends by reason of their genuine personal worth and devotion to high and lofty principles. Mr. Merical has enraged in breaking prairie and thus aiding in e development of the county, and has noted the advance in land values, while the farms have been improved from a raw state to a high

grade of development.

Dr. T. J. Caldwell, for many years one of the most prominent physicians of Adel, passed away in 1906 and his death was the occasion of deep and widespread regret. There is no man who comes into closer contact with the interests of the community and the individual than does the family physician, and a great warm heart, kindly purpose and ready sympathy endeared Dr. Caldwell to all who knew him. He was born in Indiana in 1837 and had attained the age of sixty-eight years, ten months and twenty-five days at the time of his demise. His boyhood days were devoted to farm work and to the acquirement of an educaon in the public schools. He came to Iowa in 1853, settling near Redfield in this county, but believing that he would find other pursuits more congenial than that of agriculture he determined upon a professional career and made arrangements for the study of medicine. By farm labor he earned the money to make his way through college and in 1861 he was graduated from a medical college of Keokuk. The same year he was appointed surgeon of the Twenty-third Iowa Infantry, which position he filled until the close of the war, doing effective and valuable aid for his country in his ministrations to the ill and wounded.

When the war was over and the country no longer needed him Dr. Caldwell returned to Iowa and from that time until his death was a successful practitioner of Dallas county. His ability and skill were widely recognized and brought to him a lucrative practice. He manifested strict conformity to a high standard of professional ethics and constantly broadened his knowledge by reading, experiment and close investigation. He also figured prominently in financial circles and was for many years the president of the Adel State Bank. He made extensive and judicious investments in property and in this way accumulated a comfortable fortune. He was president of the railroad built from Waukee to Adel and continued in that office after the extension of the line to Jeffer-Probably no citizen contributed more son. largely of time, money and influence for the upbuilding and improvement of Adel than did Dr. Caldwell.

On the 30th of September, 1869, Dr. Caldwell was married to Miss Malissa V. Maulsby, of Redfield, who died some years later. He afterward wedded Miss Ella Garoutte, from whom he obtained a legal separation, and in 1905 he married Mrs. Florence Pritchard, a half-sister of his first wife.

While his professional service and his business career would alone entitle Dr. Caldwell to distinction as one of the foremost residents of Dallas county, he also won notable political honors and for many years was mayor of the city. In 1881 he was elected to the legislature and subsequently was chosen to represent his district in the state senate for two terms, serving in the twentieth, twenty-first, twenty-second and twenty-third general assemblies. He made

an enviable record as a legislator, leaving the impress of his individuality upon many of the important laws and measures enacted during that period. He was one of the charter members of the Presbyterian church at Adel and in fact his name is inseparably interwoven with all lines of progress, material, intellectual, social, political and moral, connected with the development and growth of Adel and Dallas county. In his later years, because of impaired health, he spent considerable time in California but returned to Adel seemingly much improved. His death came suddenly and was the occasion of most deep and widespread regret throughout the community where he had lived for so many years and where all who knew him honored and respected him.

REV. DANIEL W. WISE.

Rev. Daniel W. Wise, whose home in on section 6, Walnut township, is one of the public-spirited citizens and progressive farmers of his locality and has a still wider acquaintance by reason of his service as a minister of the German Baptist church. He has lived in Dallas county since 1884 and his home is upon a farm of one hundred acres, which, by its splendid appearance, is proof of the life of activity and energy which he is leading.

Born in Franklin county, Pennsylvania, on the 17th of April, 1874, Rev. Wise is a son of Andrew J. and Susan (Shank) Wise. The father's birth occurred in Cumberland county, Pennsylvania, where he was reared to farm life, while later he removed to Franklin county, where he was married. In 1875 he again changed his place of abode, settling in Carroll county, Illinois, where he followed farming for nine years. On the expiration of that period he came to Dallas county, Iowa, arriving in 1884. He settled in Sugar Grove township, where he bought a half section of land and thus became closely associated with agricultural interests in this part of the state.

The Rev. Daniel W. Wise was the fifth in ; family of eight children, all of whom reached years of maturity. He was reared upon the home farm and took advantage of the schoo privileges afforded him in the neighborhood Later he attended the Dallas Center high school and was thus well equipped by a liberal educa tion for the practical and responsible duties of life. Mr. Wise taught school for three years in early manhood and then settled down to farn life. He was married on the 10th of February 1895, to Miss Flora Stech, who was also born in Franklin county, Pennsylvania, and was daughter of Samuel Stech, who settled in thi county in 1889. Following his marriage Mr Wise rented land and thus carried on farming for four years. On the expiration of that period he bought sixty acres upon which he is nov living. He has since erected a good two-stor residence here and in the rear stand good out buildings for the shelter of grain and stock including a substantial barn. He has set ou an orchard and much small fruit and has other wise improved his property until it now consti tutes one of the attractive features of the land scape. He has since added forty acres to hifirst purchase and the entire farm is well tiled while the place has been divided into fields or convenient size by well kept fences. He raise: stock of all kinds but makes a specialty of Poland China hogs.

Unto Mr. and Mrs. Wise have been born six children but they lost their firstborn in in fancy. Those still living are: Charles S. Harry A., Jacob A., Irene Elizabeth and Flora May. The family are much respected in the community and their influence is ever or the side of upbuilding, progress and improve ment. The parents are members of the German Baptist church of Sugar Grove and Mr. Wise is serving as a trustee of the local organization He is an ordained minister of the denomination and regularly preaches to the Sugar Grove and Dallas Center congregations. He also fills ap pointments at Beaver and other parts of the state and has labored with untiring zeal and devotion for the upbuilding of the cause of

TIMOTHY J. COLDWELL, M.D.,

"HE best read physician and surgeon in Dallas county, Iowa, and the most extensive practitioner, is Timothy Jourdan Coldwell, a graduate of two medical colleges. He comes from the farming class, his father, William Coldwell, living in Vermilion county, Indiana, when the son was born, on the 21st of July, 1836. The Coldwells are an old North Carolina family, extending into Virginia and Ohio, and states farther west. The grandfather of Timothy J. was a prominent Baptist minister; participated in some of the skirmishes with the Indians in Ohio, and built what is known in history as the Coldwell Block-house, located in Preble county. The maiden name of Timothy 1's mother was Mary Jourdan, who was descended from Kentucky stock. Our biographical subject developed his muscle on an Indiana farm; finished his literary education at the Newport Seminary, in his native county; came to Dallas county in 1853, and located eight miles from Adel; aided his father three years in opening a farm; commenced reading medicine in 1856 with Dr. A. M. Nelson, of Wiscotta, in the same county; attended lectures in the medical department of the State University at Keokuk, now called the College of Physicians and Surgeons, and graduated in February, 1861.

Locating at Adel, Dr. Coldwell practiced here steadily until 1864, when he joined the Union army as assistant surgeon of the 23d Iowa Infantry, serving in that capacity until the close of the rebellion.

Returning to Adel in the summer of 1865, after practicing a few months, he spent the following winter at Jefferson Medical College, Philadelphia, and has since reaped the benefit of a thorough review of medical and surgical science. He has performed the surgery in Dallas county for the last ten or twelve years, and in special cases he visits adjoining counties. He bears a high reputation, and one which is on the increase.

Dr. Coldwell is a strong, unwavering republican, prepared at any time to give a reason for his political ethics. He is an Odd-Fellow and a Royal Arch Mason. His religious membership is with the Presbyterians.

Dr. Coldwell married Miss Mellissa V. Maulsby, of Dallas county, on the 30th of September, 1860. They have no children.

The doctor has one of the finest brick residences. in Adel, and is in all respects a marked success. His physique is splendid. He has a full, ruddy complexion; a sanguine temperament; is five feet eleven and a-half inches tall; is very compact, and weighs two hundred and seven pounds. His health is perfect. He obtained his medical education at his own expense, by zealous and untiring efforts, and now stands at the head of his profession.

HON. REUBEN NOBLE,

R EUBEN NOBLE, the present judge of the tenth judicial district, was born on the 1.4th of April, 1821, near Kingston, Mississippi. His father, Henry Noble, was a farmer, and to that honorable employment the son devoted the first eighteen years of his life.
