THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Executive Vice President, Branch Operations Sector, **VOLTAIRE P. AGAS**, and its Vice President and Acting Head, Administration Group, **DORENDA DASMARIÑAS-PAN**, duly authorized pursuant to Administrative Order No. 2022-089 dated 16 November 2022 (Annex "A") and Office Order No. 2022-026-b dated 16 December 2022, (Annex "B"), hereinafter referred to as the "**SSS**";

MARLYN R. ASONIO, of legal age, Filipino, married, Owner and Single Proprietress of **HANMHE INDUSTRIAL SALES AND GENERAL SERVICES**, with principal office address at Maligaya Wet Market, FAB, Mariveles, Bataan, represented herein by her Attorney-in-Fact, **EDGAR A. ASONIO**, duly authorized pursuant to a Special Power of Attorney dated 09 November 2022 (Annex "C"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Supply, Delivery and Installation of Air-Conditioning Units for SSS Pagadian, Dagupan and Various Offices/Branches [Lot 2: Luzon Division, Branch and Service Offices]** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: FIFTEEN MILLION ONE HUNDRED THOUSAND and 00/100 (P15,100,000.00)**, Philippine currency, (hereinafter called "the Contract Price").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **PESOS: FIFTEEN MILLION ONE HUNDRED THOUSAND and 00/100 (P15,100,000.00)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to Supply, Deliver, and Install Air-Conditioning Units for SSS Luzon Division, Branch and Service Offices [Lot 2: Luzon Division, Branch and Service Offices] in accordance with its Bid.
 4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms and conditions of the Bidding.

IN WITNESS whereof, the parties hereto have caused this **AGREEMENT** to be executed in accordance with the laws of the Republic of the Philippines on the date and place indicated in their respective Acknowledgements.
