



To whom it should concern, and is also authorized plus charged with the in depth review of the arguments presented in these original actions posed ~~to~~ to the supreme court of OHIO; I would like to remind you all that the sanctity and preservation of the American form in constitutionality of justice is at stake. This writ of Mandamus is to compell the Supreme court to force either the Appeals Court or the trial court to have the TRIAL Court Under Ralph Winkler in Common Pleas Civil Jurisdiction to ~~refer~~ refer this case back to the trial court for the trial we never had under MI2022000044 or move the entire probate case out of probate back to trial in Municipal Criminal so the true criminals which are those four ladies that lied on me in the first place can be brought to justice.

I have attached the original documents I had titled as my Notice of Appeal to the MI2022000044 case as I was unaware that they had already had an appeals court case Number associated with them. In closing, I would like the Supreme Court to grant a list of reliefs I have prepared for this particular action as it is well warranted for the atrocities these courts circuits have put me, the same individual through.

1. The fact is your honor, this charge is actually involving an entire Criminal racket of organizations including our own Hamilton County Sheriff's Department whom through the advent of the Regional Narcotics Unit also known as "RENU", a state instituted Vice squad against Felonious Drug Trafficking, might be the county's number one contributor to the influx of drugs available on every floor ~~████████~~ and crevices of this jail. A complete lack of Justice as the individuals enforcing the laws, treat innocent people like me horrendously worst than the criminals that brag about death and mayhem. As a very well educated, high level physicist and mathematician, I have deduced that these institutions have created the very high increases of erratic behavior in our society and similar rising numbers of America's mental illness epidemic, hovering around 30% which by standard deviations are largely stressed to suggest that the root cause is the court system's forced medication and the jail systems dual use, as encouraged by Big-Pharma; to use these dangerous drugs for their apparent side-effects in the aid of sleep as they typically cause naps. Hamilton County sheriffs Deputies, D. Petri and D. Click, a former Deputy, now working for Butler County, a reason for my conflicting interest with court clinic. These Deputies will swear on oath that two fabricated evaluations from a doctor whom no longer works for court clinic nor is affiliated with them, forced the Defendant through a rigorous schedule of forced medications in which he tried to argue with probate court. Under Adalinda Fernandez, I was abused and tormented. I had used a very expensive Attorney by the name of Perry Anconna to accompany me in arguing my own points in court against Ralph Winkler; As racism prohibited him from acknowledging my intellect. We won in trial ~~for~~ for M12021000612 in May, Judgement for the respondent as Winkler probably guided Anconna, his buddy to use the transcripts review argument to prove Dr. K Hallly was not sworn in; But I even Reminded Anconna of that in our conference together. They were all my direct arguments. The Defendant also through his competent, unmedicated wit, was able to out smart the forced Defense attorney, Randolph Hudson and Cincinnati Prosecutors in the 21CRB12033A-E case Heard in front of the great Duane Mallory whom will confirm; that same court, under Ralph Winkler unlawfully detained me at summit in order to inhibit me from attending his criminal hearing held on the 4th of January 2022 as the Defendant. I waited till 9:00am and Around 9:30am I reach Public Defenders office and confirm whom is supervisor for felonies. I spoke to a Mike H. whom transferred me to the supervisor John Kennedy. The [redacted] phone was a Google phone prescriber or an internet phone. I explained to him that I was told by sheriffs on Social services requests to consult with my attorney to get my case numbers from Probate court for 1/7/29 and 1/19/22, at first he didn't want to do it but I reminded him that Richard Feil III, the attorney they forced on me and I never met before he did anything which was unofficial on my case, will not do it, and as I am in jail and need to file [redacted] things on those cases, Someone has to do it. He was in court at the time and had to so he used his cell phone and looked them both up. He confirmed he did not find anything so I asked him about my T.P.O. case with mother of my kids back in 2017 and he gave me the case # C1700032. I asked for the judge and he said it was not listed. Then I asked why I have my bond in my property and am still being held because the Sheriffs won't go do there jobs he did not have an answer. This is the first time I talked to him. I asked about recordings of Pub Defenders from jail calls and to have this conversation saved, He said they are not recorded. Phone call from 9:20am confirmed by Mike H. to end of call @ 9:35am. before I talked to Kennedy I again as they were handing out razors at the door by me as I was on the phone with Pub Def, I signal for a razor at D. Eastman, who for no reason said I could not get one. I was on phone getting trashed so I did not ask him why that was the case until I got off the phone. He later tells me that he would have to run around and look for me to get it back and kept procrastinating it. There were 3 deputies then, Hayes Eastman and a third I am unsure of [redacted] his name But from the very begining of that day, I had taken [redacted] Peanut Butter Packet off [redacted] tray that was a court tray and someone had smart words. I simply reply, in Africa, we don't waste food and this inmate wanted to fight me because of that statement. I ask him have you been to africa he said yes then he wanted me to go up to his cell in 41 and fight, I walked away from the situation and when he (T)

I am not the only person that noticed a conspiracy. My first Cell mate Mr. Gibbs whom just had to ride out to prison early that morning notice it with me my first moment in cell 43 with him as I explained my situation. He tried to help by secretly changing cells for me with a young boy that clearly need my help and was willing to learn so I got moved to cell 56 with Jeffery whom I was teaching the beginning concepts of trigonometry and calculus for about an hour. Another young guy (white) saw and wanted to know what I knew and came to listen. Long story short, I got along with everyone in there but that one guy that want to fight me the entire time I was there over a dominoes game and even every body at the table told him to stop being Petty. I chose to quit that game with him all together to avoid confrontation. He started it up the very next morning and was willing to miss court to fight, even though upon his return, it was confirmed that he was getting out. So as the Sheriff's saw no more people I would possibly get into it with after quite time and that everyone wanted to genuinely learn what I had to teach, they must have concocted a way internally to bring me back to psych and this can definitely be confirmed by everyone in that pod, including my friend Bosely that got out that day before quit time. These Papers are an attestation that the psych floor is involved in my placement in jail because the guys I had confrontations with in person on that floor with inmate Aaron ORR in cell 8 of N21-A was also there in 551-D as if someone was purposely trying to get me in major trouble. His Name Malikai Holland and Sgt. Shaw whom did not transport me down stairs, is on his write up sheet. He is also the person whom came up before Julie in psych and confirmed I would possibly get to shave. I told him I could use clippers cuz he offered but that I was already first on the list with D. Meiser. At 7:00pm and that I am a perfectionist and wanted it very clean first with the razor. Next thing I know, Julie comes up and a lot of lies are created just from wanting to shave. Also confirmed by Sgt. Porter is, Shaw is the guy who was suppose to take me to N21-A-7 but he was scared. He was also the Sgt. On duty when I came in.




